Overview of the feedback received for the questionnaire "Application of the International Certificate for Operators of Pleasure Craft, education and training for operators of pleasure craft"

- 1. The questionnaire has been sent to more than 70 respondents:
 - competent authorities for authorization of ICC according to annex IV to resolution No. 40;
 - other ECE member States;
 - yachting associations, in the absence of the contact information of the authorized bodies.

2. General overview of respondents

In total, 35 respondents have submitted their feedback; 21 responses of the officials from the competent authorities for authorization of ICC and 14 responses from the approved bodies for issuing of ICC, yachting associations and other entities involved in recreational navigation. The information has been received from **28 countries**, and one more country has informed that the national legislation for small and pleasure craft was under development.

In case of discrepancies between the answers from the competent authorities and other entities, the information from the competent authorities has been considered as prevailing. In the absence of answers from the competent authorities, the information from other entities has been taken into account.

3. General overview of answers is given in the table below. The secretariat has provided comments on some of them.

4. The comments are given below:

- The requirements are very different per country. If any country could issue an ICC for a European citizen, that would level out.
- It is recommended to define harmonized standards for the training courses and the exams;
- A unique program of education and exams for operators of pleasure craft should be established and harmonized for all EU Member States;
- Hopefully you can encourage more governments to participate in these ICC related working group meetings. Also other parties in addition to governments.
- The respective regulatory framework is missing. To this end, we ask for your assistance in respect of applying international provisions for issuing ICC
- The limitations for ICC could be formulated more precisely; therefore, there are differences between certain countries
- We would like to see more countries adopt Resolution 40 so that recreational boaters can be certain that their ICC will be accepted as evidence of competence for boating in other countries. Greater transparency on any restrictions on the use of the ICC would also be valuable. Steps should be taken to stop certificates which 'mimic' the ICC being issued, particularly in countries which have not adopted the ICC.
- 5. The updated information on the competent authorities may bring to modifications in annex IV to resolution No. 40.
- 6. The Group may wish to consider the answers in details and provide its recommendations for the next steps in relation to resolution No. 40 and its further work.
