# 6. Standardization of technical and safety requirements in inland navigation

#### (a) European Code for Inland Waterways (resolution No. 24, revision 5)

SC.3/WP.3 may wish to consider and preliminarily approve the draft amendments to the European Code for Inland Waterways (CEVNI) proposed by the CEVNI Expert Group at its the thirtieth and thirty-first meetings held on 18 June 2019 and 5 November 2019, back-to-back with the sessions of SC.3/WP.3 and SC.3 (ECE/TRANS/SC.3/2019/8 and ECE/TRANS/SC.3/WP.3/2020/1).

The Working Party may wish to note that amendment 3 to CEVNI revision 5, approved by SC.3 at its sixty-third session, and the consolidated version of amendments 1 to 3 are available on the SC.3 website.

SC.3/WP.3 will be informed about the outcome of the thirty-second meeting of the CEVNI Expert Group to be held on 11 February 2020, back-to-back with the fifty-sixth session of SC.3/WP.3.

The Working Party may wish to continue discussion on updating CEVNI based on the comparison with the Police Regulations for the Navigation of the Rhine prepared by the secretariat (ECE/TRANS/SC.3/WP.3/2019/15 and ECE/TRANS/SC.3/WP.3/2020/2) as well as the navigation rules of the Danube Commission and the International Sava River Basin Commission and provide guidance for the CEVNI Expert Group.

SC.3/WP.3 will be informed about the preparatory work for the sixth revision of CEVNI and may wish to provide further guidance to the CEVNI Expert Group and the secretariat.

Following the decision at its fifty-fifth session to update the appendix to resolution No. 21 "Reception facilities for the transfer of waste generated on board ships on European inland waterways", based on ECE/TRANS/SC.3/WP.3/2019/3 (ECE/TRANS/SC.3/WP.3/110, para. 65), the Working Party may wish to start the discussion on this issue. Member States are invited to inform SC.3/WP.3 on any updates to the list of reception facilities on their national inland waterways.

# 7. Provisions for passenger daily trip vessels

The Working Party may wish to continue discussion on special provisions for passenger daily trip vessels, based on the amendment proposal to the annex to resolution No. 61 on a draft new chapter 19A, "Special provisions applicable to passenger vessels not exceeding 24 m in length and authorised to carry up to a maximum of 150 passengers" by the Confederation of European Maritime Technology Societies (CEMT).

SC.3/WP.3 may also wish to continue discussion on the various aspects related to passenger daily trip vessels, including traffic management systems, responsible authorities and traffic regulation rules, which was begun at the sixty-third session of SC.3, and to consider follow-up steps.

# 8. River-sea transport in Europe

Following the decision at its fifty-fifth session to discuss the outcome of the workshop on river-sea transport held on 11 September 2019 in Duisburg (Germany) by the Central Commission for the Navigation of the Rhine (CCNR) and the overview of the CCNR thematic at fifty-sixth session report on river-sea-transport its (ECE/TRANS/SC.3/WP.3/110, para. 17), the Working Party may wish to consider the main conclusions made at the workshop and the main findings of the thematic report transmitted by CCNR, complement this information with additional data as well as consider and provide recommendations for SC.3 for the promotion and development of river-sea transport in Europe.

The Working Party may wish to start discussion on updating the annex to resolution No. 79, "International Standard for Electronic Ship Reporting in Inland Navigation", based on Commission Implementing Regulation (EU) 2019/1744 on technical specifications for electronic ship reporting in inland navigation of 17 September 2019 (Informal document SC.3 No. 5 (2019)) and provide guidance to the secretariat.

### (c) Other resolutions of the Economic Commission for Europe of relevance to River Information Services

The Working Party may wish to exchange information about the implementation of RIS by governments and river commissions.

### (d) Danube Information Services Conference

# 10. Mutual recognition of boatmasters' certificates and harmonization of professional requirements in inland navigation

At its fifty-fourth session, the Working Party decided to consider updating the Recommendations on Minimum Requirements for the Issuance of Boatmaster's Certificates in Inland Navigation with a view to their Reciprocal Recognition for International Traffic (resolution No. 31, revised) and asked the secretariat to hold consultations with the European Committee for drawing up standards in the field of inland navigation (CESNI) on this issue (ECE/TRANS/SC.3/WP.3/108, paras. 37-38). SC.3/WP.3 may wish to start the discussion on updating provisions of the annex to resolution No. 31 based on the standards for qualifications in inland navigation professional requirements, included in the European Standard for Qualification in Inland Navigation (ES-QIN), adopted in 2018.

For this purpose, SC.3/WP.3 may wish to consider the standards of competence and the standards for technical and functional requirements applicable to simulators and radar simulators transmitted by the European Committee for drawing up standards in the field of inland navigation and provide guidance to the secretariat. The Working Party may also wish to come back to the outcome of the workshop "Education standards and professional requirements in inland navigation" held at its fifty-fourth session and discuss follow-up steps.

Member States and River Commissions are invited to inform SC.3/WP.3 about recent progress in this field.

The Working Party may wish to decide on a theme topic for its fifty-sixth session or to choose from previous proposals: (a) Building an inland waterway infrastructure that is resilient to climate change, and (b) Inland water transport and sustainable cities.
