Corrigendum to the consolidated version of draft amendments to the 11th revised edition of the Model Regulations on the Transport of Dangerous Goods

Corrigendum 1

The following corrections apply to the English version of the consolidated version of draft amendments to the 11th revised edition of the Model Regulations on the Transport of Dangerous Goods.

Chapter 3.1

3.1.2.8.1.1 A mend the end of the paragraph to read:

"... only ISO common name(s), other name(s) in the W orld Health O rganization (WHO) Recommended Classification of Pesticides by Hazard and Guidelines to Classification, or the name(s) of the active substance(s) may be used. ".

Chapter 3.3

SP 63 Add "dispenser" after "aerosol" in the introductory sentence and at the end of "(c)".

In (d), am end at the beginning "... the propellant of aerosol to be... " to read: "... the propellant of aerosol dispensers to be... ".

SP265 This special provision had already been deleted. (See

ST/SG /A C . 10/1/Rev. 11/Corr. 1).

SP302 A mend "requirements" to read "provisions".

Chapter 4.1

4.1.1.1 A mend "... and loadings normally encountered during transport, including transshipment between transport units and/or warehouses as well as any removal from a pallet or overpack for subsequent... " to read:

"... and loadings normally encountered during transport, including trans-shipment between transport units and between transport units and warehouses as well as any removal from a pallet or overpack for subsequent...".

4. 1. 3. 8. 2 A m end "4. 1. 10. 1" to read "4. 1. 3. 8. 1".

Chapter 5. 4

- 5. 4. 1. 4. 3 (b) A m end "... road transport tanks and railway transport tanks)... " to read " ... tank-vehicles and tank-wagons)... ".
- 5.4.1.5.4 A mend the title to read: "Substances stabilized by temperature control".
- 5. 4. 1. 5. 5 Delete this paragraph and renumber subsequent paragraphs and sub-paragraphs accordingly.
- 5. 4. 3 (c) A mend to read as follows:

"Provision of a separate document, such as the International C ivil Aviation O rganization (IC A O) "Emergency Response G u idance for A ircraft Incidents Involving Dangerous G oods" or the International M aritime O rganization (IMO) "Emergency Procedures for Ships Carrying Dangerous G oods" and "M edical First A id G u ide in Accidents Involving Dangerous G oods", for use in conjunction with the transport documents.".
