The Executive Secretary of the United Nations Economic Commission for Europe, as Secretary of the Agreement, communicates the following:

On 17 November 2005, at its fifteenth session, the Executive Committee of the Agreement, in accordance with para. 7.1. of article 7 of Annex B to the Agreement, at the request of the United States of America (TRANS/WP.29/2005/101) determined by affirmative vote (TRANS/WP.29/1047, para. 90) to list in the Compendium of Candidates the following technical regulations:

Federal Motor Vehicle Safety Standard; FMVSS No. 213 Child Restraint Systems and FMVSS No. 225 Child Restraint Anchorage Systems

The above technical regulations were listed No. 9 in the Compendium of Candidates.

The following document is appended to the above technical regulations:

Federal Motor Vehicle Safety Standards; Child Restraint Systems; Child Restraint Anchorage Systems; Final Rule

Final Economic Assessment FMVSS No. 213 and FMVSS No. 225 Child Restraint Systems, Child Restraint Anchorage Systems

Reference is made in this respect to article 5. paras. 5.2., 5.2.2 and 5.2.3. of the Agreement, which read as follows:

"5.2. Listing technical regulations in the Compendium of Candidates

Any Contracting Party may submit a request to the Executive Committee for the listing in the Compendium of Candidates of any technical regulation that such Contracting Party has applied, is applying or has adopted for future application.

- 5.2.2. The Executive Committee shall consider all requests that satisfy the requirements of Article 4 and paragraph 5.2.1. of this Article. The technical regulation shall be listed in the Compendium of Candidates if supported by an affirmative vote in accordance with paragraph 7.1. of Article 7 of Annex B. The documentation submitted with the request for that regulation shall be appended to the listed technical regulation.
- 5.2.3. The requested regulation shall be considered to be listed by the Secretary-General on the date on which it is supported by an affirmative vote under paragraph 5.2.2. of this Article."
