A. PROPOSAL

Annex 3, paragraph 9.2.2.1., amend to read:

"9.2.2.1. For vehicle category M1 in test area A, extended to the median plane of the vehicle, and in the corresponding part of the windscreen symmetrical to it about the longitudinal medium plane of the vehicle, and also in the reduced test area B according to paragraph 2.4. of annex 18."

Annex 3, paragraph 9.4., amend to read:

"9.4. IDENTIFICATION-OF-COLOURS TEST

When a windscreen is tinted in the test areas defined in paragraphs 9.2.5.1., 9.2.5.2. or 9.2.5.3., four windscreens shall be tested for identifibiality of the following colours in test area B defined in annex 18 paragraph 2.3., excluding any opaque obscuration impinging on it:

white, selective yellow, red, green, blue, and amber."
