**(a) Presentation of activities of the Working Group on Implementation**

The Conference of the Parties, at its first meeting, established the Working Group on Implementation (ECE/CP.TEIA/2, annex III, decision 2000/2) to monitor the implementation of the Convention, prepare reports on the Convention's implementation, and draw conclusions and make recommendations.

Mr. Bernard Gay (Switzerland), Chairman of the Working Group on Implementation, will report on the outcome of the Group's three meetings held since the third meeting of the Conference of the Parties: Warsaw, 14 September 2005, Geneva, 15 December 2005 and Vienna, 3–5 April 2006. The first two meetings were held jointly with the Bureau in preparation for and as follow-up to the High-level Commitment Meeting.

He will also report on the outcome of the training session on drawing up national implementation reports (Warsaw, 12–13 September 2005).

The Conference of the Parties is invited to discuss the outcome of the work of the Working Group on Implementation and endorse the report of the training session.

**(b) Presentation of the third report on the implementation of the Convention**

The Working Group's Chairman will inform the Conference of the Parties on the status of reporting on the implementation of the Convention by Parties and other UNECE member countries within the third round of reporting.

The Chairman will then introduce the third report on the implementation of the Convention, including its conclusions and recommendations, prepared by the Working Group on the basis of the reporting forms that it received from Parties and other UNECE member countries. The third report will reflect a change of emphasis from a mainly quantitative to a more qualitative assessment of the national implementation reports by the Working Group. He will focus on the following:

(i) Identification and notification of hazardous activities

Information will be provided on the status of the identification of hazardous activities by Parties and the process of notifying them to the potentially affected neighbouring countries.

Parties that have not yet identified their hazardous activities within their jurisdiction and notified their neighbouring countries will have an opportunity to explain their delay in complying with the above provision of the Convention.

(ii) Establishment of bilateral cross-border cooperation under the Convention

Insight will be provided into the bilateral discussions and cooperation that were undertaken and reported by Parties in order to exchange information and draw up joint preparedness and response measures.

(iii) Challenges in implementing/acceding to the Convention

The key challenges to implementation of/accession to the Convention that were reported to the Working Group will be highlighted.

**(c) Discussion and adoption of the third report on the Convention's implementation**

The Conference of the Parties is invited to discuss and evaluate the process of reporting on implementation. Parties that did not report on the implementation of the Convention will have an opportunity to explain their lack of reply.

The Conference of the Parties is invited to adopt the third report on the implementation of the Convention as contained in ECE/CP.TEIA/2006/2.

**(d) Good practices in implementing the Convention**

The delegation of Hungary agreed to share its experience in establishing and expanding cooperation arrangements with neighbouring countries. The Conference of the Parties will have an opportunity to hear the delegation's presentation.

**(e) Election of members of the Working Group on Implementation for 2007–2008**

According to the terms of reference of the Working Group on Implementation (ECE/CP.TEIA/2, annex III, decision 2000/2, appendix), the Conference of the Parties is invited to elect up to 10 members of the Working Group from among the candidates nominated by Parties for a term to last until its next meeting.

At its third meeting, the Conference of the Parties elected Ms. Anahit Aleksandryan (Armenia), Mr. Armin Heidler (Austria), Mr. Nikolay Savov (Bulgaria), Mr. Pavel Forint (Czech Republic), Mr. Leo Iberl (Germany), Ms. Judit Mogor (Hungary), Mr. Massimo Cozzone (Italy), Mr. Dmitri Y. Poletaev (Russian Federation), Mr. Tomas Trcka (Slovakia) and Mr. Bernard Gay (Switzerland) as members of the Working Group on Implementation. In accordance with the terms of reference, the members of the Working Group are eligible for re-election.

**(a) High-level Commitment Meeting**

Mr. Zaal Lomtadze (Georgia), Chairman of the High-level Commitment Meeting, and Mr. Grosset will report on the key outcome of the High-level Commitment Meeting, in particular on the declaration adopted by the heads of delegations of countries of Eastern Europe, Caucasus and Central Asia (EECCA) and South-Eastern Europe (SEE) (CP.TEIA/2005/12, annex).

**(b) Report on the results of the preparatory phase of the assistance programme**

In accordance with the assistance programme (CP.TEIA/2004/2, chapter V, para. 52), the Secretary, on behalf of the outgoing Chairperson and the Chairman of the Working Group on Implementation, will present an overall report on the results of the programme's preparatory phase, in particular on the outcome of fact-finding missions to countries of EECCA and SEE.

The Conference of the Parties is invited to endorse the report on the results of the preparatory phase of the assistance programme. It is also invited to take a decision qualifying the candidate EECCA and SEE countries to take part in the implementation phase of the programme. The Parties may also wish to decide on the modalities for taking similar decisions with regard to countries that will be visited after this meeting.

**(c) Panel discussion on the outcome of the first cluster of fact-finding missions**

Mr. Ernst Berger, Mr. Ludwig Dinkloh, Mr. Bruno Frattini, Mr. Ryszard Grosset, and Mr. Kees van Kuijen, the team leaders who have led fact-finding missions thus far, will report on their impressions and experience gained during their missions. They are invited to make recommendations for the fact-finding missions that will take place after the meeting. The Conference of the Parties is invited to express its views and may wish to give guidance to future fact-finding teams.

**(d) Presentation of the draft action plan for the implementation phase of the assistance programme**

The secretariat will present the draft action plan for the implementation phase of the assistance programme, including the proposed capacity-building activities for the next two years (2007–2008) and the required human and financial resources needed to implement them.

**(e) Discussion and adoption of the draft action plan**

The Conference of the Parties is invited to discuss the implementation of the draft action plan, including the provision of the required financial resources, and subsequently to adopt it.

#### **(a) Review of annex I to the Convention by the Working Group on the Development of the Convention**

The Conference of the Parties, at its third meeting, established the Working Group on the Development of the Convention (ECE/CP.TEIA/12, annex IV, decision 2004/4) to review, as a priority, annex I to the Convention and submit, if appropriate, recommendations and proposals for amending the Convention.

Mr. Tobias Biermann (European Commission), Chairman of the Working Group, will report on the outcome of the Group's review of annex I to the Convention with a view to updating it and achieving as much convergence with the annex of the "Seveso II" Directive as possible and appropriate. The Group held two meetings – in Geneva on 20 May 2005 and 28 March 2006 – and a number of smaller consultations.

As a result of the above, the Group agreed on a proposal to amend annex I to the Convention and through its Chairman submitted it together with a draft decision to the Bureau of the Conference of the Parties. The Bureau, at its ninth meeting in Warsaw on 22–23 May 2006, endorsed the proposal and the draft decision.

#### **(b) Presentation of the Group's proposal to amend annex I to the Convention**

The Working Group's Chairman will present the draft decision amending annex I to the Convention, to which the Group's proposal is annexed. This document will have been circulated to the Parties before the meeting in accordance with article 26, paragraph 2, of the Convention.

**(c) Discussion and adoption of the draft decision to amend annex I**

The Conference of the Parties is invited to discuss the proposal and the related draft decision (ECE/CP.TEIA/2006/6) and subsequently adopt it. If adopted by the Conference of the Parties, the amendment will be communicated to the Parties and recommended for approval in accordance with article 26, paragraph 4 (a), of the Convention.

**(a) Outcome of the second consultation for points of contact for the purpose of accident notification and mutual assistance designated within the UNECE IAN System**

The Conference of the Parties, at its first meeting, decided that the points of contact designated for the purpose of accident notification and mutual assistance within the UNECE IAN System should review the System regularly to monitor its operability and effectiveness (ECE/CP.TEIA/2, annex I, decision 2000/1).

Mr. Fabrizio Colcerasa (Italy), Chairman of the second consultation, will report on its outcome (CP.TEIA/2005/11, Part I). The consultation was held on 19–20 October 2005 in Rome, back-to-back with the first meeting of the task force to review the communication procedures under the UNECE IAN System.

The Secretary will provide information on the current status of the network of points of contact and will report on the recent tests of the UNECE IAN System.

Parties that have not yet designated points of contact or whose points of contact were not operational during the test will have an opportunity to explain their delay in complying with the relevant provisions of the Convention.

The Conference of the Parties is invited to discuss the outcome of the consultation, the recommendations made by its participants and the results of the tests.

**(b) Outcome of the first meeting of the task force to review the communication procedures within the UNECE IAN System**

At their third meeting, the Parties established a task force to review the communication procedures within the UNECE IAN System (ECE/CP.TEIA/12, para. 58).

Ms. Giuliana Gasparri (Italy), who chaired the first meeting of the task force, will report on its outcome (CP.TEIA/2005/11, Part II. The meeting was held on 21 October 2005 in Rome.

The secretariat will briefly introduce the simple Web-based notification application developed jointly by the UNECE and the Joint UNEP/OCHA Environment Unit and will present the steps required to implement the recommendation of the task force to enhance the communication procedures within the UNECE IAN System.

The Conference of the Parties is invited to discuss the proposal by the task force to enhance the communication procedures within the UNECE IAN System by introducing Web-based technology notifications.

**(c) Adoption of the decision on increasing the effectiveness of and enhancing the communication procedures within the UNECE IAN System**

**(a) Progress report of the Joint Ad Hoc Expert Group on Water and Industrial Accidents**

Mr. Gerhard Winkelmann-Oei (Germany), Co-Chairman of the Joint Expert Group will present the Group's progress report containing information on accomplished tasks, challenges in its work and a proposal for a future work plan.

Mr. Grosset will inform the Conference of the Parties about the outcome of a meeting between the Chairpersons of the governing bodies of the Industrial Accidents and Water Conventions to discuss issues of common concern (Geneva, 25 April 2006). The Chairmen recognized the achievements of the Joint Expert Group, agreed with the proposed elements of its future work plan (including their order of priority) and committed to striving to increase awareness of the Group's activities, especially among experts representing the Water Convention.

Mr. Manuel Varela (Spain), Chairman of the Meeting of the Parties to the Convention on the Protection and Use of Transboundary Watercourses and International Lakes, will address the Conference of the Parties.

The Conference of the Parties is invited to discuss the progress report, in particular the future work plan of the Joint Expert Group, as well as the issues addressed in the introductory statements. Finally, it is invited to endorse the report and to adopt the Group's future work plan.

**(b) Report on the implementation of the conclusions and recommendations of the seminar on the prevention of chemical accidents and limitation of their impact on transboundary waters in Central and Western Europe**

The Conference of the Parties, at its first meeting, endorsed the conclusions and recommendations of the Seminar on the Prevention of Chemical Accidents and Limitation of their Impact on Transboundary Waters (ECE/CP.TEIA/2, annex VI, decision 2000/5) and requested Parties to implement them by 2005 (for market-economy countries) and by 2010 (for countries with economies in transition) and report to the Conference of the Parties and the Meeting of the Parties to the Water Convention. The Joint Expert Group was given the task of seeking the relevant information from the Parties and preparing an overall report on the implementation of these conclusions and recommendations.

The Conference of the Parties is invited to review the implementation of the Hamburg recommendations, based on the Joint Expert Group's report, and to subsequently endorse it.

**(c) Safety guidelines and good practices for pipelines**

The Conference of the Parties and the Meeting of the Parties to the Water Convention requested the Joint Expert Group to prepare safety guidelines and good practices for pipelines (ECE/CP.TEIA/2, annex VI, decision 2000/5). At its third meeting, the Conference of the Parties supported the Group's proposal to include two workshops, one focusing on the safety of oil pipelines and the other on the safety of gas pipelines, in the process of drawing up the guidelines (ECE/CP.TEIA/12, paras. 50–51). The Joint Expert Group established a steering group with expertise on pipelines to draw up the guidelines.

The delegations of Germany and the Netherlands (host countries) and the secretariat will inform on the outcome of the workshops on:

- (i) The Prevention of Water Pollution Due to Pipeline Accidents (Berlin, 8–9 June 2005); and
- (ii) The Prevention of Accidents of Gas Transmission Pipelines (The Hague, 8–9 March 2006).

The Joint Expert Group's Chairman will introduce the guidelines, which have been drawn up by the steering group, considered by the Joint Expert Group at its seventh meeting in Geneva on 10–11 April 2006 and finalized by the Group's co-chairmen after a final consultation round among Parties to the Conventions and representatives of the private sector, in particular of pipeline operators.

The Conference of the Parties is invited to endorse the guidelines and good practices.

#### **Item 12. Protocol on Civil Liability and Compensation for Damage Caused by the Transboundary Effects of Industrial Accidents on Transboundary Waters**

The Secretary will briefly recall the main decisions taken by the Parties to the Industrial Accidents and to the Water Conventions at their second joint special session, held in Kiev on 21 May 2003, in particular the adoption of the Protocol on Civil Liability and Compensation for Damage Caused by the Transboundary Effects of Industrial Accidents on Transboundary Waters. He will also recall the decisions taken by the Conference of the Parties in this respect at its third meeting.

Mr. Grosset and Mr. Varela will refer to the outcome of their meeting (Geneva, 25 April 2006). In particular, they will introduce a proposal to organize a consultation (in place of a formal third joint special session of the two governing bodies) among the Parties to both or one of the Conventions in order to review the reasons for the current ratification status of the Protocol (one ratification) and the steps taken by UNECE member countries to ratify it.

The Conference of the Parties is invited to discuss the proposal and its possible involvement in and further contribution to promoting the Protocol's early entry into force.

**(a) Priorities and work plan**

The Conference of the Parties is also invited to decide on its priorities and the elements of the work plan for 2007–2008 on the basis of a proposal made by the Bureau (ECE/CP.TEIA/2006/13, para. 2 and annex I, respectively). In doing so, it may also wish to take into account the long-term programme of work under the Convention and the outcome of its discussions on the previous agenda items (in particular the assistance programme).

**(b) Resources**

The Secretary will report on the use of resources under the Convention in 2000–2006 on the basis of a note (ECE/CP.TEIA/2006/12), which the Conference of the Parties is invited to endorse.

The Conference of the Parties is also invited to decide on funding arrangements under the Convention and the budget to facilitate the implementation of the work plan for 2007–2008 on the basis of a proposal made by the Bureau (ECE/CP.TEIA/2006/13, annex II).

The Conference of the Parties may also wish to make arrangements to support the participation of experts from countries with economies in transition in meetings held under its auspices and in the activities within the assistance programme. It is therefore invited to decide on criteria for such support, taking into account a proposal made by the Bureau (ECE/CP.TEIA/2006/13, annex III).

**(c) Draft decision on the priorities, programme of work and resources under the Convention for 2007–2008**

The Conference of the Parties is invited to officially adopt its decision on the priorities, work plan and resources under the Convention for 2007–2008, taking into account the outcome of the discussions on the previous two items (13 (a) and (b)).

**Item 14. Date and venue of the fifth meeting of the Conference of the Parties**

The Conference of the Parties is invited to take a unanimous decision to hold its fifth ordinary meeting in 2008. Delegations are encouraged to offer to host the fifth meeting so that the Conference of the Parties can decide on its next venue.

**Item 15. Other business**

At the time of writing, the secretariat had no points to propose under this item.

**Item 16. Review of decisions and final statements**

The Chairperson will review all the decisions taken by the Conference of the Parties at its fourth meeting. The Conference of the Parties is invited to entrust the Secretary, in consultation with the Bureau, with finalizing the report of its fourth meeting.

**Item 17. Final statements and closing of the meeting**

The Chairperson and representatives of the host country will be invited to make final statements. The Chairperson will then officially close the fourth meeting of the Conference of the Parties.
