

- * Water diplomacy & consideration geopolitical and regional integration benefits of TWC higher on the diplomatic agenda
- * Outcomes: recommendations on how to identify, assess and communicate the regional integration & geopolitical benefits of TWC → input to Guidance

2. Draft Policy Guidance Note on benefits of cooperation: main messages

- * Benefit assessment exercises can help countries realize the potential value of cooperation
- * Benefit assessment exercise to be closely tied to a transboundary water cooperation policy process, and designed to match its needs (cf. level of maturity)
- * Broad range of benefits of TWC, varying according to basins context

* Nature & level of detail of "assessment phase" to vary according to issues, cooperation stage & political will

Pre-initial stage	Establish conditions for launching cooperation process	Identify mutually beneficial opportunities from shared water resources	Rapid qualitative assessment of key benefits
Initial stage	Launch of cooperation process	Identification of full range of benefits	Rapid qualitative assessment of all identified benefits
Medium stage	Consolidation of cooperation process through negotiations	Broad assessment of range of benefits of cooperation, incl. cost of non action	In-depth qualitative assesst of all identified benefits & some quant. & monetary estimates
Advanced stage	Realization of potential benefits of cooperation, implementation of cooperation initiatives	Assessment of benefits of independent national / joint projects or a basin programme of measures	Quantitative and monetary valuation, when justified given available resources

- Communication to be tailored to different audiences, purposes and the stage of TWC policy process
