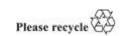

#### II. Annotations

- 1. The fourth session of the Meeting of the Parties to the Protocol on Water and Health to the Convention on the Protection and Use of Transboundary Watercourses and International Lakes (Water Convention) will be held from 14 to 16 November 2016, at the Palais des Nations in Geneva, at the invitation of the Government of Switzerland.
- 2. The session will comprise a high-level segment followed by a general segment. The high-level segment, dealing with agenda items 1 to 4, will be held on the morning of Monday, 14 November, starting at 10 a.m. The general segment, addressing agenda items 5 to 12, will start on Monday at 3 p.m. and run until 5.30 p.m. on Wednesday, 16 November.
- 3. A number of side events will be organized during the meeting. The detailed programme of these side events will be available in October 2016. Additional practical information on the meeting as well as all relevant documentation will be made available in due course on a dedicated page on the Protocol's website.<sup>1</sup>

- 7. The joint secretariat of the Protocol will inform the Meeting of the Parties about the status of ratification of the Protocol on Water and Health.
- 8. Delegates from States or regional economic integration organizations not yet Party to the Protocol will be invited to briefly present their plans to ratify, accept, approve or accede to the Protocol.
- 9. In accordance with the rules of procedure for the meetings of the Parties to the Protocol (ECE/MP.WH/2/Add.1–EUR/06/5069385/1/Add.1), the Bureau will report on the credentials submitted by the Parties.<sup>3</sup> Parties to the Protocol are therefore invited to inform the secretariat of the name(s) of their representative(s) at their earliest convenience, and to submit the credentials or a copy of them to the ECE secretariat by **4 November 2016**. Those Parties that have submitted a copy of the credentials should present the originals to the secretariat before the fourth session of the Meeting of the Parties, on their arrival at the meeting in Geneva.

Tentative timing: Monday, 14 November, 11–11.10 a.m.

- 10. In accordance with its rules of procedure, the Meeting of the Parties will elect a chair and two vice-chairs. The Chair and Vice-Chairs will remain in office until the next elections at the fifth session of the Meeting of the Parties.
- 4. Special session on moving forward on the water and sanitation agenda in the pan-European region: the role of the Protocol on Water and Health in achieving the 2030 Agenda for Sustainable Development

Tentative timing: Monday, 14 November, 11.10 a.m.-1 p.m.

- The 2030 Agenda for Sustainable Development (2030 Agenda) and its Sustainable Development Goals will shape the dynamics in which the international community approaches its main challenges. In the pan-European region, the Protocol on Water and Health has supported remarkable progress in water, sanitation and health in recent years, in particular in terms of access to water and sanitation, the quality of drinking water and the reduction of water-related disease. There are still many challenges that require further attention. The region has not met the Millennium Development Goal target on sanitation. It still faces an unacceptable burden of water-related disease and significant inequities in access to water and sanitation services remain, including with respect to rural-urban disparities and in institutions such as schools and hospitals. Realizing the effects of global drivers such as climate change and urbanization, there is a need to increase the resilience of water supply and sanitation systems to extreme weather events, including growing water scarcity, and to strengthen safe and efficient management approaches of water and sanitation services, including specific attention to wastewater reuse. Generally, intersectoral cooperation between the water, health and other relevant sectors needs to be further enhanced to effectively deal with the problems at stake. All these issues, which are part of the ambitions of the 2030 Agenda, have been recognized as priorities under the Protocol.
- 12. The 2030 Agenda sets ambitious objectives to be achieved in the next 15 years. Reaching them will require stepping-up efforts in the region; more efficient approaches and stronger cross-sectoral partnerships are therefore essential. The Protocol features a number of strengths that make it very relevant to support meeting the 2030 Agenda commitments across the pan-European region.
- 13. The Protocol's provisions and work are fully aligned with Sustainable Development Goal 6 "Ensure availability and sustainable management of water and sanitation for all" and relevant targets under Goal 3 "Ensure healthy lives and promote well-being for all at all ages". The Protocol also clearly supports the implementation of other Sustainable Development Goals pertinent to water, sanitation and health, specifically Goal 1 on ending poverty, Goal 2 on improving nutrition, Goal 4 on equitable quality education, Goal 11 on safe, resilient and sustainable cities and Goal 13 on combating climate change and its impacts.
- 14. With a strong integrated and intersectoral approach, its focus on the coherence of policies and its attention to inclusivity and equity issues, the Protocol's objectives, principles and approaches are consistent with the 2030 Agenda. Moreover, the Protocol's legally binding nature, which allows it to channel long-term efforts, and its intergovernmental framework open to all stakeholders makes it possible for the Protocol to respond to changing and varying needs across the region.

- 15. The Protocol can therefore be a powerful tool to promote and operationalize the achievement of the 2030 Agenda in national and regional contexts. Its planning and accountability approach through target setting and reporting offers a practical framework for Parties to translate the ambitions of the 2030 Agenda into specific national targets and actions. The Protocol also offers a pan-European hub for all relevant stakeholders to build evidence, strengthen political commitment, develop policy and technical guidance, build capacities and share experiences and good practices for attaining the 2030 Agenda targets on water, sanitation and health.
- 16. The special high-level session will foster a strategic discussion between Parties, other States, international and non-governmental organizations and academia on the different perspectives on and expectations for advancing the water and sanitation agenda in the pan-European region and in particular how the Protocol can best fulfil its potential role in this respect and support countries and other stakeholders in their efforts.
- 17. A keynote presentation will set the scene and highlight the vision, challenges and opportunities for achieving the water, sanitation and health-related Goals and targets under the 2030 Agenda, enriched by the lessons learned from efforts to achieve the Millennium Development Goals and evidence from science.
- 18. A panel composed of high-level representatives from countries, international and non-governmental organizations and the private sector will discuss implementation of the 2030 Agenda with regard to water, sanitation and health, and the role of the Protocol, around the following questions:
- (a) How will the 2030 Agenda with its aspirations and drive impact on your water, sanitation and health policies, initiatives and programmes? What will be the main opportunities and challenges?
- (b) How can silos be broken and interlinkages and cooperation promoted among all relevant sectors, including environment, health, education, nutrition, financing and infrastructure? What cross-sectoral partnerships need to be strengthened to advance the 2030 Agenda on water, sanitation and health issues?;
- (c) What have been the main successes of the work of the Protocol so far and what are the implications of the 2030 Agenda for its future work? How can the Protocol, its governance structure and its activities best support the implementation of the relevant Sustainable Development Goals?
- 19. Subsequently, Parties, other States and stakeholders will be invited to participate in an interactive moderated discussion on the above issues. Due to the limited time available, interventions and statements should not exceed three minutes. To facilitate the running of the special session, delegations planning to make a statement are invited to inform the secretariat in advance.

#### (a) Setting targets, implementing measures and reporting under the Protocol

Tentative timing: Monday, 14 November, 3.10-6 p.m.

- 22. The Chair of the Task Force on Target Setting and Reporting will present the outcomes of the work of the Task Force in the past triennium. In particular, the Meeting of the Parties will be informed about the elaboration and publication of the Collection of Good Practices and Lessons Learned on Target Setting and Reporting under the Protocol on Water and Health, prepared based on the experience of countries and organizations in setting and implementing targets and reporting in accordance with the Protocol. The Meeting of the Parties will be invited to endorse the Collection, which will complement the Guidelines on the Setting of Targets, Evaluation of Progress and Reporting.<sup>4</sup>
- 23. With reference to article 6, paragraph 3, of the Protocol, those Parties that have yet to establish and publish targets will be invited to report on progress achieved in the setting of targets. Participants will be invited to discuss the specific challenges encountered by Parties when setting targets and existing solutions and lessons learned. Participants will also be invited to highlight how other areas of work under the Protocol have influenced target setting at the national and local levels.
- 24. The Meeting of the Parties will be invited to review the implementation of the Protocol on the basis of the national summary reports submitted by Parties during the third

reporting cycle and the regional report prepared by the joint secretariat. It is also expected to take note of reports submitted by signatories and other States not Party to the Protocol.

- 25. Participants will be invited to discuss the main trends, challenges and solutions emerging from the reporting exercise of 2015–2016.
- 26. The Meeting of the Parties will be briefed on developments related to the global framework for monitoring of the Sustainable Development Goals pertinent to water, sanitation and hygiene, as well as on the regional highlights on water and sanitation from global monitoring programmes, such as the WHO/United Nations Children's Fund (UNICEF) Joint Monitoring Programme for Water Supply and Sanitation (JMP) and the UN-Water Global Assessment and Analysis of Sanitation and Drinking Water (GLAAS).
- 27. The Chair of the Task Force will introduce the draft decision on reporting in accordance with article 7 of the Protocol, including guidelines and a template for summary reports. The Meeting of the Parties will be invited to discuss and adopt the decision.
- 28. The lead Parties for this area of work will present future planned activities for 2017–2019. The Meeting of the Parties will discuss the proposal.

In accordance with article 16, paragraph 3 (c), of the Protocol, the Chair of the Meeting of the Parties to the Water Convention will inform the Meeting of the Parties to the Protocol of the progress made in the implementation of the Water Convention, the decisions taken at the seventh session of the Meeting of the Parties to the Convention (Budapest, 17–19 November 2015), especially regarding the globalization of the Convention, the implementation of the programme of work and the opportunities for joint action by the two governing bodies.
- 53. Parties will also be informed about the preparations for the Sixth Ministerial Conference on Environment and Health to be held in 2017, including the status of development of possible targets and commitments on water, sanitation and health to be included in the Conference's outcome document. The Meeting of the Parties will be invited to discuss the proposed commitments, as well as interlinkages and synergies between the European Environment and Health Process and the future priorities of work under the Protocol.
- 54. Partners from international and non-governmental organizations have been crucial in implementing the Protocol's programme of work for 2014–2016. Existing and potential partners from international organizations and non-governmental organizations will be invited to present ideas and proposals for cooperation in the framework of the programme of work for 2017–2019.

# 8. Programme of work for 2017–2019, terms of reference of bodies established to implement it and resources needed for its implementation

Tentative timing: Wednesday, 16 November, 2.30-4.30 p.m.

- 55. The joint secretariat will provide an overview of the financial resources that were made available for the implementation of the programme of work for 2014–2016, highlighting specific challenges encountered as a result of lack of funds.
- 56. The Chair will recall that, at its third session, the Meeting of the Parties requested the Bureau to examine the possibilities for a sustainable financing mechanism to support implementation of future programmes of work, to review decision I/5 on the financial arrangements to support the implementation of the Protocol and to present a draft decision in that regard for consideration at the next session of the Meeting of the Parties. The Bureau subsequently presented a proposal for a draft decision on a sustainable financing arrangement under the Protocol to the Working Group on Water and Health at its eighth meeting (Geneva, 21–22 October 2015). Following discussions at that meeting and at the sixteenth meeting of the Bureau (Geneva, 10 March 2016) and also taking into account the outcomes of similar processes to introduce sustainable financial mechanisms under other ECE multilateral environmental agreements it was determined that there was not enough consensus at the present stage to introduce a sustainable financial mechanism under the Protocol. The Bureau then decided to prepare an informal document, "Overview and consolidation of financial arrangements". The Meeting of the Parties will take note of the informal document.
- 57. On the basis of the discussions under previous agenda items, the Meeting of the Parties is expected to finalize and adopt its programme of work for 2017–2019. In doing so, the Meeting of the Parties will:
- (a) Agree on the structure of the programme of work, future activities, lead countries and partners;
- (b) Agree on the intergovernmental bodies, along with their respective mandates, to guide the implementation of the programme of work;
- (c) Make arrangements related to the financial and human resources needed to implement the activities in the programme of work, and indicate funding for these activities according to their priority. Parties, other interested States and organizations are invited to inform the joint secretariat in advance of the session of their intention to contribute financially to the programme of work's implementation. The joint secretariat will make the information received available to the Meeting of the Parties and delegations will be invited to provide any supplementary information.
