Background documentation on past reviews and barriers to implementation and ratification to the Convention's Protocols

Presented by the Gothenburg Protocol Review Group (GPG)

Air pollution is a significant problem in Eastern Europe, Caucasus and Central Asia (EECCA) as well as in other countries that have not yet ratified the Gothenburg Protocol as amended in 2012, despite the new flexibilities that were included.

The document “Preparations for the review of the Protocol to Abate Acidification, Eutrophication and Ground-level Ozone as amended in 2012 (ECE/EB.AIR/2020/3) recommends an informal session be held during a meeting of the Working Group on Strategies and Review to discuss barriers and ways forward toward ratification and implementation of the amended Gothenburg Protocol (i.e., political willingness, knowledge and technical support, needed legislation and regulations, and funding).

To begin preparing for a potential informal session for discussion and to include additional information in the current Review of the Gothenburg Protocol, the GPG collected important background documents for the Review as well as documents that have already been prepared to provide a basis for continuing the discussion on increased ratification and implementation of the Convention and its Protocols. Additional information to guide discussions on this topic at a session of the WGSR would be helpful and an official document is recommended.
