INTRODUCTION

- ▶ **Development of a programme of measures for reduction of air pollution in Montenegro, paying special attention to emissions of SO_x, NO_x, PM, NH₃ and VOC;**
- ▶ **Updated National Strategy of Air Quality, beyond 2020;**
- ▶ **EU Directive 2016/2284, the CLRTAP and several of its Protocols;**
- ▶ **Methodology for policy development, monitoring and implementation of strategic documents**

ANALYSIS OF CURRENT STATE

PLANNING ACTIVITIES

- ▶ **The policy options that have been considered to meet emission reduction obligations between 2020 and 2029 and beyond 2030 as well as the medium-term reduction commitments set for 2025 to further contribute to improving air quality and data analysis including the methods of analysis, where available, the individual and combined effects of policies and measures to reduce emissions, air quality and the environment and associated uncertainties;**
- ▶ **The measures and policies that are planned for adoption, as well as the timetable for adoption, application and audit, and the responsible bodies;**
- ▶ **Where relevant, an explanation as to why the indicative emission level for 2025 can not be achieved without the imposition of disproportionate costs;**
- ▶ **Where relevant, a report on the application of the flexible provisions laid down in Article 5 and the environmental consequences caused by the application of those provisions;**
- ▶ **An examination of how the policies and measures selected ensure consistency with the plans and programs established in other relevant policy areas.**
