#### (d) <u>Discussion of individual chapters</u>

Individual chapters will be discussed in the order and timeframe outlined in part III of this agenda.

Up to 35 minutes will be allocated to each chapter for discussion. This slot of time will be organized in the following way:

- Introduction to the chapter by the reviewers, members of the Expert Group: 5 minutes first reviewer, 5 minutes second reviewer
- Reply by the country: 5 minutes
- Discussion on the draft recommendations: up to 20 minutes.

Recommendations will be discussed in the order that they appear in the respective chapter in the report.

#### (e) <u>Concluding remarks</u>

The Chair will invite the delegation of Romania to make a concluding statement.

#### 4. Other business

The secretariat will report on the activities conducted in 2020 in the framework of the United Nations Development Account Project "Evidence-based environmental governance and sustainable environmental policies in support of the 2030 Agenda in South-East Europe".
