## 2015- 2019: Global Action Programme on ESD







1,514 strategic ESD policy documents supported



providing technical support for policy development, implemented at the country level





139,093 learning institutions supported



37,669,951 learners



3,549,839 youth leaders supported



741,438 youth leaders trained as trainers



2,148,873 teacher educators participated in capacity-building activities



39,798 teacher training institutions supported



13,086 networks/civil society organizations conducted ESD activities



**5,517 ESD activities/programmes** established by local authorities



## **UN General Assembly resolution on ESD**

#### **UN General Assembly Resolution 72/222**

Reaffirms UNESCO as the lead agency for ESD

Reaffirms education for sustainable development as a vital means of implementation for sustainable development, as outlined in the Aichi-Nagoya Declaration on Education for Sustainable Development, and as an integral element of the Sustainable Development Goal on quality education and a key enabler of all the other Sustainable Development Goals, and welcomes the increased international recognition of education for sustainable development in quality education and lifelong learning;

#### **UN General Assembly Resolution 74/223**

**Encourages Governments to increase efforts** to systemically integrate and institutionalize education for sustainable development in the education sector and other relevant sectors, as appropriate, including through, inter alia, the provision of financial resources, the inclusion of education for sustainable development in relevant policies and the development of the capacities of policymakers, institutional leaders and educators, as well as through the strengthening of research and innovation, and monitoring and evaluation on education for sustainable development in order to support the scaling up of good practices; (...).

#### ESD's contribution to the achievement of SDGs

- 1. All ESD activities contribute to the achievement of the SDGs, even without explicit reference
- ESD can enhance the understanding on sustainable development through communication and advocacy in educational settings on SDGs
- 3. ESD can promote critical and contextualized understanding of the SDGs by raising questions on the inter-linkages and tensions among different SDGs



#### 4. Monitoring of indicator 4.7.1.


- 7<sup>th</sup> global consultation on the progress of 1974 Recommendation concerning Education for International Understanding, Co-operation and Peace and Education relating to Human Rights and Fundamental Freedoms
- The extent to which ESD and GCED are mainstreamed at all levels in national education policies, curricula, teacher education and student assessment
- Questionnaire: sent to the governments, due by end of December 2020


