Background

The workshop on Information Management and Public Participation in Transboundary Water Cooperation is organized within the framework of the project *Capacity for Water Cooperation (CWC) in Eastern Europe, the Caucasus and Central Asia* (EECCA), developed under the work programme of the UNECE Convention on the Protection and Use of Transboundary Watercourses and International Lakes. The project aims to strengthen the capacity of transboundary water management in EECCA through cross-fertilization and exchange of experience between ongoing projects, river basins and countries on different aspects of integrated management of transboundary waters. CWC also aims to establish a network of EECCA experts involved in transboundary water management (http://www.unece.org/env/water/cwc.htm).

The GEF International Waters Learning Exchange and Resource Network (IW:LEARN), the World Bank Institute and the Swedish Environmental Protection Agency fund the workshop. The workshop is prepared in cooperation with the Peipsi Center for Transboundary Cooperation and IW:LEARN. IW:LEARN serves to strengthen the Global Environment Facility's International Waters projects by promoting information sharing and learning among stakeholders. The workshop is also part of a series of regional workshops IW:LEARN co-hosts around the world on information management and public participation. Hence, experiences and lessons from EECCA will be transferred to other regions through subsequent workshops.

The workshop has two main themes. The first is information management for transboundary water cooperation, including information needs for integrated management, information exchange between different actors involved and information utilization for decision-making and for stakeholders' information. The second theme is public participation, including methods for its development, stakeholders identification and involvement in decision-making.

The workshop participants are representatives of national authorities and NGOs actively involved in transboundary water management in the EECCA region, including in on-going GEF projects on international waters. They are not only recipients of the training but also trainers. Therefore participants are expected to prepare contributions and reports on the themes of the workshop to allow for a comprehensive and systematic exchange of the best practices in the region.

During each session, the presentations will be followed by general discussion, questions and answers. Participants who want to prepare specific interventions related to the session's themes are welcome to do so.
