The workshop "Water and Adaptation to Climate Change: Joining Efforts to adapt" is organized under the auspices of the UNECE Convention on the Protection and Use of Transboundary Watercourses and International Lakes (Water Convention) and of its Protocol on Water and Health, under the joint leadership of the Governments of Germany, Italy, and the Netherlands, with the support of the UNECE and WHO/EURO, and in collaboration with the United Nations Educational, Scientific and Cultural Organization (UNESCO) and the World Meteorological Organisation (WMO).

The Workshop will take stock of progress and difficulties in designing and implementing strategies to adapt to climate change in the water, environment and health-related sectors, both within the national and transboundary contexts. Through concrete examples, the workshop will illustrate the different components of effective adaptation strategies, including legal, institutional, technical and financing aspects and promote the sharing of good practices and lessons-learned in the UNECE region. The workshop will thus assist governments in the UNECE region to make adaptation happen both in their domestic water and the related health policies and in their cooperation on transboundary waters.

The workshop will also be an important step in the preparation of a Guidance on water and adaptation to climate change, currently under development under the Water Convention and its Protocol on Water and Health in view of its possible adoption by Parties to both instruments.
