- * For the specific target of increased access to drinking water from 92.63% to 100% and hygienic sanitation the necessary resources are provided from the municipal budget of Kratovo
- * For the specific target of increased access to drinking water from 97.2% to 100% and hygienic sanitation, the necessary resources are provided from the municipal budget of Kriva Palanka
- * For the specific target of increased access to drinking water from 69.6% to 100% and hygienic sanitation, the necessary resources are provided from the municipal budget of Staro Nagoricino

- * For the specific target of increasing public funding from the municipal budget intended to improve access to water and sanitation, the necessary resources are provided from the municipal budget.
- * For the specific target of raising public awareness on the impact of the environment on health, the necessary resources are provided from the municipal budget, the national budget and donations.
- * For the specific target of increasing the rate of access to hygienic sanitation in rural areas, the necessary resources are provided from the City of Skopje, Skopje's plan region, municipality, local communities, donations (Japan embassy fund, SAICM, OPEC fund).

- * For the specific target of increasing the rate of access to a centralized sanitation system in rural area, the necessary resources are provided from the municipal budget, national budget, donations(IPARD), civil sector.
- * For the specific target of improving monitoring of safety of drinking water, the necessary resources are provided from the municipal budget, national budget.
- * For the specific target of increasing the rate of access to hygienic sanitation in urban areas, the necessary resources are provided from the municipalities, plan regions, donations.

- * For the specific target of improved secure infrastructure for public water supply, the necessary resources are provided from the municipal budget, national budget, donations.
- * For the specific target of improving water quality of local water supply systems, the necessary resources are provided from the municipal funds and funds from local communities, citizens, funds for rural development, donations (TAEX, IPA2), PCE.
- * For the specific target of providing universal access to safe drinking water, sanitation and promoting basic hygiene in school environment, the necessary resources are provided from the municipal budget, national budget, donations.

- * For the specific target of providing universal access to safe drinking water, sanitation and promoting basic hygiene in religious objects, the necessary resources are provided from the municipal budget, national budget, donations.
- * For the specific target of providing universal access to safe drinking water and sanitation to people with disabilities, the necessary resources are provided from the municipal budget.
