2. Draft model provisions on transboundary groundwaters

Tentative timing: 10.10 a.m.–1 p.m. and 3–6.00 p.m., Monday, 11 June 2012, and 9.30 a.m.-12.30 p.m. and 2.30 – 4.00 p.m., Tuesday, 12 June 2012

- 5. The Meeting of the Parties to the Convention at its fifth session mandated the Legal Board and the Working Group on Integrated Water Resources Management to prepare a preliminary study on the application of the principles of the Convention to transboundary groundwaters, to be submitted to the sixth session of the Meeting of the Parties for consideration as to whether further action was needed.
- 6. The Legal Board had addressed the application of the principles of the Convention to transboundary groundwaters at its seventh, eighth and ninth meetings (Geneva, 15–16 April 2010, 24–25 February 2011 and 1–2 September 2011, respectively). Following the consultation with the Bureau of the Meeting of the Parties (Geneva, 9 March 2011) and the Working Group on Integrated Water Resources Management at its sixth meeting (Geneva, 4–5 May 2011), the proposal to develop model provisions on transboundary groundwaters had been endorsed by both the Bureau and the Working Group on Integrated Water Resources Management (ECE/MP.WAT/WG.1/2011/2) with a view to having the set of model provisions ready for possible adoption at the sixth session of the Meeting of the Parties. Furthermore, the Working Group on Integrated Water Resources Management had decided to create a Core Group on Groundwater in order to develop those model provisions, and had requested nomination of national legal and technical experts for that activity.
- 7. At its first meeting (Geneva, 30 January 2012), the Core Group on Groundwater discussed the Draft Model Provisions on Transboundary Groundwaters (LB/2012/INF.1) submitted by the Chair and the Vice-Chair of the Legal Board and agreed upon a number of revisions to the above-mentioned document, including, inter alia, the expansion of commentaries and addition of relevant examples to showcase good practices. It mandated the Chair and the Vice-Chair of the Legal Board to work on the new version of the model provisions and agreed on two rounds of commenting by members of the Core Group on Groundwater.
- 8. The Core Group on Groundwater will discuss the revised draft of the model provisions submitted by the Chair and the Vice-Chair of the Legal Board and further elaborate the text by taking decisions on the drafting language so as to submit the document for endorsement by the Working Group on Integrated Water Resources Management at its seventh meeting (Geneva, 3–4 July 2012) allowing the submission of the draft model provisions on transboundary groundwaters to the sixth session of the Meeting of the Parties (Rome, 28–30 November 2012).
