- High-level forest policy process in Europe
- Policies for sustainable forest management
- Ministerial commitments and follow-up actions
- Open platform for dialogue
- 18 years of cooperation 47 Signatories
- 5 ministerial conferences



MCPFE: overall achievements

- Solid platform for pan-European cooperation
- Framework for global-regional interface
- Developed a conceptual frame for Sustainable Forest Management (SFM) in Europe:
 - Definition and General Guidelines
 - Criteria and Indicators
 - Operational Level Guidelines



Warsaw ministerial conference – 5th MCPFE, 5-7 November 2007

- Warsaw Declaration
- Warsaw Resolution 1 "Forests, Wood and Energy"
- Warsaw Resolution 2 "Forests and Water"



Why Forests and water?

Context:

- Water shortage (quality and quantity)
- Biodiversity
- Natural hazards (erosion, floods, droughts, forest fires)
- Climate change
- Financial basis full economic value of forests

Measures outside the sector:

- Water Convention
- EU Water Framework Directive (EU Groundwater Directive)
- Ramsar Convention
- United Nations Convention on Combating Desertification (UNCCD)

• Measures inside the forest sector:

- Warsaw Declaration and Resolutions Follow-up
- Afforestation Guidelines (ongoing)
- Cross-sectoral cooperation



Warsaw Resolution 2 "Forests and Water":

- I. Sustainable management of forests in relation to water
- II. Coordinating policies on forests and water
- III. Forests, water and climate change
- IV. Economic valuation of water-related forest services



Coordinating policies on Forests and Water:

- "Develop and improve policies for forest and water resources management..."
- "Coordinate forest and water resources management policies..."
- "...improve the existing institutional arrangements to better cooperate in addressing the interrelation between forest and water issues."
- (...)
- "Encourage joint activities of the forest and water sectors and enhance cooperation between the MCPFE and the Water Convention (Warsaw Declaration)"

MCPFE Work Programme

- adopted May 2008

- Two scientific conferences on forests and water:
 - Poland, 14-17 September 2008
 - Barcelona, 30-31 October 2008
- Workshop: "Water related ecosystem services and implications for forest and water policies", Turkey 2009
- Workshop: "Pan-European approaches for development of measures to secure multiple forest ecosystem services", 2010



"Water related Ecosystem Services and implications for forest and water policies", Turkey 2009

- Proposed for May 2009
- Bring knowledge and experiences a step further
- Cooperation and dialogue between sectors
- Explore implications for forest and water policies:
 - Interrelations between forests and water
 - Broaden the financial basis for SFM, e.g. Payments for ecosystem services (PES), other measures
 - Evolve coherence between water management plans (e.g. IWRM) and national forest programmes (NFP)
