#### Do we need a roadmap?

- High interest in the Convention by non-ECE countries, opening is beneficial for both sides
- The "opening" process is not a straightforward task, it has many aspects to be taken into account
- It is a medium-long term effort, it needs a "vision" on where to go
- UN 1997 Convention: where to go together?

#### **THEREFORE**

 The Bureau decided in April to develop a draft, it will be discussed at its meeting tomorrow afternoon

#### What the roadmap would provide

- Takes into account accomplished steps
- Identifies present and future needs and opportunities
- Defines practical steps, with timelines when feasible
- Foresees new strategic directions

• The Roadmap should be a "living document", to be continuously adapted to changing circumstances

#### Possible outline of the roadmap

- Foster ratification of amendment by "Madrid" Parties
  - Promotion outside UNECE region
  - Relationship with UN 1997 Convention
    - Support to non-UNECE countries
      - Working in partnership
        - Financing

#### Promotion outside UNECE region

- Promotion at different levels, incl. At Global events
- Subregional workshops (e.g. Latin America, Africa, Arab States, Asia/Pacific, etc.)
- Involving non-UNECE countries in Convention activities
- Use alternative channels (global processes, MoFAs)

#### Relationship with UN 1997 Convention

- Promote synergy and coordination
- Sharing experience
- Start open debate on joining forces (capacity building, assistance programmes, financing, institutional framework)
- Common communication messages

### Support to non-UNECE countries

- Need for a guidance on how to cooperate with interested countries
- Possible factors to take into account:
  - Level of interest expressed in the Convention
  - Level of interest in technical activities under the Convention
  - Level of interest in cooperating with neighbours
  - Shared basins with UNECE region
  - Level of funding available/provided

### Working in partnership

- International organizations
- Global Conventions
- Global IFIs, GEF
- Other UN regional Commissions and UN agencies

### **Financing**

- Need for additional resources:
  - Participation of countries outside UNECE region
  - Resources for the Secretariat
  - Promotion initiatives at global level
  - Pilot projects outside UNECE region

#### Opportunities:

- Global financing mechanisms, GEF
- Development cooperation agencies, MoFAs, other sources (global donor community)

- Workshop co-organized with ECLAC, UNESCO, GEF, IUCN,
  B.A. University of Bologna, IGRAC
- <u>89 participants</u> from all but one Latin American countries plus two Caribbean countries (Haiti, Dominican Republic)
- Participants included lawyers, diplomats and technical experts

## Where <u>Latin American Countries</u> are already involved or expressed interest

- Three countries from the region participated to the Rome MoP in Nov. 2012: Nicaragua, Honduras, Colombia
- A few countries already participating in technical activities (e.g. Workshops on Adaptation to Climate Change and Task Force on Climate and Water)

- Making use of international legal instruments on water for advancing cooperation
- Jointly adapting water management to climate change and variability in transboundary basins
- Reconciling different interests and uses in transboundary basins, their requirements and compatibility for good water governance
- Fostering transboundary water cooperation in the Latin American and Caribbean region and UNECE region and between them
