## RATIFICATION STATUS OF THE WATER CONVENTION, ITS AMENDMENDS AND ITS PROTOCOLS

### Note by the secretariat

#### Introduction

- 1. The present document sets out the ratification status of the UNECE Water Convention, its amendments and its Protocols.
- 2. As of 30 October 2009, 35 UNECE member countries and the European Community are Parties to the Convention.
- 3. The amendments to articles 25 and 26 of the Convention did not yet enter into force. As of 30 October 2009, 14 countries ratified or accepted the amendments.
- 4. The 1999 Protocol on Water and Health to the 1992 Convention on the Protection and Use of Transboundary Watercourses and International Lakes was signed by 36 countries and ratified, accessed, accepted or approved by 24 Parties, as of 30 October 2009. The Protocol on Water and Health entered into force on 4 August 2005.
- 5. The Protocol on Civil Liability and Compensation for Damage Caused by the Transboundary Effects of Industrial Accidents on Transboundary Waters to the 1992 Convention on the Protection and Use of Transboundary Watercourses and International Lakes and to the 1992 Convention on the Transboundary Effects of Industrial Accidents was signed in Kiev in 2003 and it has not yet entered into force. As of 30 October 2009, 24 countries signed the Protocol and one country ratified it.
