

- Following countries have comprehensive and complete data set:
 - Armenia, Azerbaijan, Belarus (2008-2010), Kazakhstan (most of 2009 is missing, high figures in last three years), Moldova, Russia (2010 is missing)
- Following countries have incomplete data set:
 - Georgia (data only for 2007 and incomplete), Kyrgyzstan (data only for 2010), Tajikistan (no data), Uzbekistan (complete data only for agriculture & etc, municipal waste and hazardous waste)
 - Ukraine has used two formulas to calculate waste data for other economic activities and total amount. However, it is confusing.
 Different classes of toxicity, but definition not provided. Very high figures in 2010
- No country reported on hazardous municipal waste

- General observations
 - Mining and quarrying is the major contributor to total waste generation
 - Definitions of hazardous waste should be harmonized

 - No: Armenia, Georgia, Moldova, Russia, Ukraine, Uzbekistan
- Following countries have used m³ instead of tones to report on municipal waste, need for harmonization
 - Kyrgyzstan, Russia, Tajikistan, Uzbekistan
