### Introduction

The seventy-second session of the Committee on Forests and the Forest Industry (COFFI) will be held, at the kind invitation of the Government of the Russian Federation, in the city of Kazan, from 18 to 21 November 2014.

- A regional contribution to the eleventh session of the United Nations Forum on Forests (New York, May 2015).
