## Action plan to promote accession to and implementation of the TIR Convention and the eTIR international system, including intermodal aspects of the TIR Convention

### Note by the secretariat

- 1. The audit of the management of the TIR Trust Fund conducted by the United Nations Office of Internal Oversight Services (OIOS) recommends that ECE should develop an action plan for providing the required training and support to countries that have acceded to the TIR Convention to operationalize the TIR procedures in those countries (see Recommendation No. 10 in ECE/TRANS/WP.30/AC.2/2019/25).
- 2. The audit also mentions that the Terms of Reference (ToR) of the TIR Executive Board (TIRExB) stipulate that the TIR secretariat shall undertake the task of providing information, interpretation and support for training on the application of TIR procedures, particularly for countries that have recently acceded to the Convention. OIOS noted that eight countries (Montenegro, the United Arab Emirates, Pakistan, China, India, State of Palestine, Qatar and Saudi Arabia) had acceded to the TIR Convention since October 2006, of whom five countries were operational. The TIR secretariat was yet to provide training in the required administrative procedures to these eight countries since their accession to the Convention, as well as support for the establishment of administrative procedures. The TIR secretariat needed to take the required measures in operationalizing the TIR system in these countries.
- 3. TIRExB, at its eighty-second session (June 2019), took note of the recommendation made by OIOS and considered that priority should be given to it as there were many new accessions to the TIR Convention. The Board, while appreciating the efforts by IRU and some contracting parties so far, was of the view that there needed to be an organized approach by the secretariat to the activation of the TIR system in new contracting parties. It also recalled that its programme of work envisaged preparation of an action plan to provide the required training and support to countries that have recently acceded to the TIR Convention in the establishment of administrative procedures, in line with Article 8 (f) of its ToR. The secretariat clarified that an action plan would allow a follow-up with newly acceded countries for the establishment of the administrative procedures. The secretariat added that there were new challenges ahead, such as eTIR and the intermodal use of the TIR procedure, and that, thus, the intention was to draft a more strategic document, covering plans about events to be organized to promote those topics.

- 4. TIRExB, at its eighty-third session (October 2019), agreed with the action plan drafted by the secretariat and requested it to be submitted to the Administrative Committee for the TIR Convention, 1975 (AC.2) at its February 2020 session for consideration and approval, as also recommended by OIOS.
- 5. The Administrative Committee may wish to consider and adopt the proposed action plan.
