

Post Covid-19 Recovery Action Plan for Informal Settlements in the UNECE Region Validation Workshop

Rationale

In the context of the drafting of the *Post COVID-19 Recovery Action Plan for Informal Settlements in the UNECE Region*, designed to respond effectively the COVID-19 challenges and to increase urban resilience against future pandemic threats, UNECE and the Global Environmental Policy Programme at the University of Geneva organize this **Recovery Action Plan Validation Workshop**.

The objective of the validation workshop is to present and review the main policy areas of the Action Plan, share the underpinning data collected in four pilot cities, and collect feedback from leading experts, as well as local and national representatives.

The validation workshop addresses the following **three main areas**: "Built environment and Infrastructure", "Access to Goods and Services" and "Engagement, Inclusivity and Justice".

- The **first area** focuses on provisions related to buildings and land planning; physical infrastructure and utilities; green spaces and recreation.
- The **second area** includes discussion on the provision of food and key services; basic consumption and distribution needs; as well as access to and use of data and information technology.
- The **third area** focuses on the involvement of local communities and neighborhoods, including land rights, tenure and justice in informal settlements, as on the impacts of stayat-home recommendations on vulnerable groups.

Each of these areas will be introduced by **the lead authors** of the Plan. This will be followed **by feedback to be provided by a panel of experts in each area.** Experts come from the UNECE Nexus Team on Smart and Sustainable Cities for All Ages, Academia and Civil Society. Discussion will be informed by **data collected by the assessment teams** on the informal settlements of four pilot cities (Bishkek, Kyrgyzstan; Podgorica, Montenegro; Skopje, North Macedonia; Tirana, Albania). Participants will be invited to provide their input and feedback during the discussion session of each panel.
