Semi-Annual Meeting of Specialist Centres of Excellence (New Orleans, Louisiana, 3 to 6 March 2020)

- The Specialist Centres of Excellence met to discuss how resilience should be integrated into infrastructure and PPP projects.
- A representative from ECLAC participated.
- Key learnings:
 - Governments by themselves cannot build resilience;
 - The threat from further calamities and storms is high;
 - PPPs are important vehicles for meeting the challenges and threats at different stages;
 - Innovative ways should be harnessed by these PPPs to take forward a greener and sustainable response to building resilience;
 - People must come first; and
 - Louisiana can be the hub and a source of knowledge and expertise for other communities around the world.
- Outcome:
 - The Specialist Centres of Excellence agreed to develop Guidelines on integrating resilience in infrastructure projects and PPPs and on promoting resilient communities, under the auspices of the International Centre on Sustainable Resilience based in New Orleans.

 - Strengthened the institutional capacity of Tajikistan to identify and prepare People-first PPP projects.

 - Organised jointly with the PPP Center, the Resident Coordinator Office and UNDP.
 - Promoted the role of People-first PPPs in support of the SDGs with a focus on strengthening the PPP legal and regulatory framework in Tajikistan.

Follows the policy advisory services provided by UNECE in 2019 on the identification and preparation of People-first PPP projects.

 Development of guidelines and template documents for public officials to implement the new PPP Law covering the different phases of the PPP process (request for qualification, request for proposal, PPP agreement, monitoring procedure).
