1. Since the entry into force, on 1 January 2012, of the amendments to Annex 9, Part I of the TIR Convention, 1975, one of the obligations of national associations is to provide the TIR Executive Board (TIRExB), annually, before 1 March, with the price of each type of TIR Carnet it issues.

II. Information received

2. In 2012, the secretariat received information from 10 associations. In 2013, 2014, 2015, 2016, 2017, 2018 and 2019, 48, 49, 50, 51, 48 and 50 associations, respectively, provided TIRExB with data on the prices of each type of TIR Carnets they issue.

3. To date, 50 associations have provided TIRExB with the 2020 prices.

4. The prices received for 2012, 2013, 2014, 2015, 2016, 2017, 2018, 2019 and 2020, converted to United States dollars (USD)¹, are presented in Annexes I, II, III, IV, V, VI; VII, VIII and IX.

III. Analysis

5. At its sixty-third session, the Administrative Committee of the TIR Convention, 1975 (AC.2) considered the preliminary analysis of the 2015 TIR Carnet prices, as contained in Annex V of document ECE/TRANS/WP.30/AC.2/2016/2. It was of the view that the analysis provides useful information in fulfilment of the mandate of TIRExB to monitor TIR Carnet prices and should be repeated annually and reported to the Committee whenever significant changes in TIR Carnet prices are identified.

6. Annex X contains the analysis of the 2020 TIR Carnet prices.

IV. Disclaimer

7. The prices charged by the various issuing associations are not always comparable. Some associations report prices including taxes (e.g. VAT) and fees (e.g. insurance fees) while others do not include some or all of these taxes and fees in the prices they report. Furthermore, national practices, such as the obligation to deposit an amount of money with the association or the payment of annual membership fees, also have an influence on the prices charged for TIR Carnets.

V. Survey on TIR Carnet prices

8. At the request of TIRExB at its seventy-ninth session (ECE/TRANS/WP.30/AC.2/2019/11, para. 40), the secretariat circulated a new questionnaire on TIR Carnet prices for the year 2020. The new questionnaire clearly requests issuing associations to report the prices including all taxes and fees. The 2020 questionnaire remained identical. To date, 49 issuing associations replied to the questionnaire (i.e. used by all associations that replied but one).

VI. Considerations by TIRExB

9. TIRExB considered the prices of TIR Carnets for the year 2020 together with an analysis by the secretariat. Taking note that no significant changes had arisen since the last survey, TIRExB instructed the secretariat to publish 2020 prices on the TIRExB website and submit the prices and analysis to AC.2 at its February 2021 session.

VII. Considerations by the Committee

10. The Committee may wish to take note of the prices presented in Annexes I, II, III, IV, V, VI, VII, VIII and IX as well as the results of the analysis of the 2020 TIR Carnet prices contained in Annex X.

Annex X

Analysis of 2020 TIR Carnets prices

I. Introduction

At its sixty-first session, AC.2 welcomed document ECE/TRANS/WP.30/AC.2/2015/4, containing an assessment by the secretariat and various suggestions received from Contracting Parties (Belarus, European Union, Switzerland and Turkey), on the need for an analysis or a specific methodology for TIRExB to analyse the price information of TIR Carnets in detail. The Committee was of the view that the methodology proposed by the secretariat could be used to conduct a first pilot analysis by TIRExB, which at first would be kept restricted and could later be repeated annually if proved conclusive. Consequently, the Committee requested TIRExB, with the assistance of the secretariat, to work on the pilot analysis and report back to the Committee at one of its future sessions.

In document ECE/TRANS/WP.30/AC.2/2015/4 the secretariat proposed, as a first trial, to run a linear regression to analyse a number of variables whose data could be found for all countries providing the issuing prices and which could explain the variability of the prices, such as wages or the number of TIR Carnets issued.

At its sixty-third session, AC.2 considered the preliminary analysis of the 2015 TIR Carnet prices, as contained in Annex V of document ECE/TRANS/WP.30/AC.2/2016/2. It was of the view that the analysis provides useful information in fulfilment of the mandate of TIRExB to monitor TIR Carnet prices and should be repeated annually and reported to the Committee whenever significant changes in TIR Carnet prices are identified.

Annex 5 Chapter II in document ECE/TRANS/WP.30/AC.2/2016/2 contains the theoretical discussion on the formation of TIR Carnet prices that led to the underlying analysis.

II. Data

Associations from Afghanistan, Albania, Armenia, Austria, Azerbaijan, Belgium, Bosnia and Herzegovina, Bulgaria, China, Croatia, Czech Republic, Denmark, Estonia, Finland, France, Georgia, Germany, Greece, Hungary, India, Iran (Islamic Republic of), Italy, Jordan, Kazakhstan, Latvia, Lebanon, Lithuania, Mongolia, Montenegro, Netherlands, Norway, Pakistan, Poland, Republic of Moldova, Romania, Russian Federation, Serbia, Slovakia, Slovenia, Spain, Sweden, Switzerland, Syrian Arab Republic, Tajikistan, Turkey, Turkmenistan, United Arab Emirates, United Kingdom of Great Britain and Northern Ireland and Uzbekistan have sent TIRExB the 2020 prices of the TIR Carnets they issue. By subtracting the distribution prices by IRU, the association premiums can be obtained.

Table X.1 shows the associations that have a different issuing price for their members or national transporters compared to non-members or foreign transporters.

Considering that most TIR Carnets are sold to members or domestic transporters, the analysis is carried out on the prices for members or domestic transporters.

As a proxy of the number of TIR Carnets issued in 2019 by each association, the number of TIR Carnets distributed by IRU to the associations (TOT¹⁰) is used. The correlation of the number of TIR Carnets distributed with the weighted average association premiums (WAVGM) is -0.4069228.

From the International Monetary Fund World Economic Outlook data sets from October 2019, the 2019¹¹ data for the following variables have been considered as possible proxies of the countries' cost levels:

- NGDPDPC : Gross domestic product per capita, current prices (USD)
- PPPPC : Gross domestic product based on purchasing-power-parity (PPP) per capita (International USD)

The correlation of these series with the weighted average association premiums are 0.1156707, respectively, -0.03718579. Considering that the correlation of the premiums with PPPPC is negative and in the absence of a better proxy, the analysis thus uses NGDPDPC as a proxy for the countries' cost levels despite its relatively low correlation value with the premiums.

¹⁰ For associations not having received TIR Carnets in 2019 we set TOT to 1 to be able to calculate the logarithm of TOT.

Box plots




Figure X.1 shows the box plots of all the variables that have been considered (WAVGM, TOT and NGDPDPC). In view of the possible non-linear relation between the variables, their logarithmic transformations have also been plotted (LWAVGM, LTOT and LNGDPDPC).

III. Regressions

In order to evaluate the possible influences of the envisaged explanatory variables (separately and jointly), the following regressions were performed:

$$Y = \alpha + \beta \cdot X + \varepsilon \tag{1}$$

$$Y = \alpha + \beta \cdot \log(X) + \varepsilon \tag{2}$$

$$\log(Y) = \alpha + \beta \cdot X + \varepsilon \tag{3}$$

$$\log(Y) = \alpha + \beta \cdot \log(X) + \varepsilon \tag{4}$$

where Y is WAVGM and X is TOT, NGDPDPC or [TOT NGDPDPC].

In all the regressions, the coefficients of NGDPDPC or LNGDPDPC, combined or not with TOT or LTOT, were not significant and in some cases even negative (a positive relation is expected between the costs' proxy and the premium). Figure X.2 show the regression lines over the plotted data.

Therefore, from a statistical perspective, the best model tested is:

$$\log(\text{WAVGM}) = \alpha + \beta \cdot \text{TOT} + \varepsilon \tag{5}$$

Table X.2 presents the regression results and shows that both α and β are significant but that the R2 value is quite low, indicating that the price setting is most likely also influenced by other variables.

When inserting the regression results in equation 5, it reads

$$\log(\text{WAVGM}) = 4.005 - 1.184 \cdot 10^{-05} \cdot \text{TOT} + \varepsilon \quad (6)$$

Figure X.3 shows equation 6 (solid line), the average log(premium) (dashed line) as well as the [LWAVGM, TOT] data plotted for each association. The figure shows that comparing the association premiums with the average premium does not take into account the effect of the volumes of issuance of TIR Carnets.

Plots of data with regression lines





IV. Trends

Table X.3 shows the historical prices of 14 Volets TIR Carnet prices (in USD), issued to members or national transporters for each association since 2012, as well as trend lines and inter annual variations. In 2020, when looking at the prices in USD, 12 associations have increased their prices, 24 have decreased the prices and 4 left the prices unchanged. However, when converting the prices to EUR, only 19 associations have increased their prices, 8 decreased them and 13 remain unchanged. This shows that a large share of this variability is due to fluctuations in exchange rates.

V. Conclusions

In conclusion, this analysis of the 2020 prices confirms that the principle of economies of scale is generally respected in the price setting for TIR Carnets. As in the analysis of the

2015, 2016, 2017, 2018 and 2019 prices, there is no statistical evidence that associations in countries with higher GDP per capita charge higher premiums.
