- Feb 2019: ToS Meeting in Koli, Finland to discuss modelling results
- After JWP 2019: Preparation of the study outline by the Secretariat
- Sept 2019: Lead authors meeting in Zvolen, Slovakia
 - Back-to-back with 3rd FORMASAM meeting
- Beginning of drafting of the FSOS
- Nov 2019: ToS Meeting to present outline/first drafts of individual chapters
- March 2020: Side meeting with contributing authors in Potsdam, Berlin
 - During 4th FORMASAM meeting
- COVID-19 slowed drafting process down

 - Written feedback and comments by many ToS members prior to the event

Capacity building 2020 – Collaboration with the Russian Federal Forestry Agency

- Training event on forest sector outlook modelling and its use of results in practice
- 2-day online event, 17-18 November 2020, with simultaneous translation
- 15 speakers from different UNECE member States
- Wide range of participants from different institutions of the Russian Federation

- Chapter 1-4 edited, 5 and 6 remaining
- Final review by authors, UNECE and FAO currently under way
- Submission to printing department foreseen in April/May
- Printing department generally needs minimum 2 months



Dissemination ideas

FORESTS

- Sending of printed versions to key government stakeholders
- Publication on UNECE webpage, together with methodology report and country level data
- Official launch event this summer
 - Most likely online, will allow for a wide range of participants
 - Accompanied with official press release, maybe short and simple video if resources allow
- Conference presentations in Europe, North America (ISFRE 2021)
- Publicly directed newsletter (UNECE Billboard)
- Dissemination through member States and ToS members
 - Social media Twitter, FB, Instagram
 - News releases, other media
- Potentially including data in INForest (forest-data.unece.org/)
- Possibly engaging the Forest Communicators Network ToS
