## About the checklist

- Aimed at supporting countries in the design and drafting of agreements or other arrangements for transboundary waters
- Focus on content and drafting options rather than on process
- Target audience: Country representatives, legal and technical experts, policy decision-makers involved in negotiation of agreements or other arrangements for transboundary waters, the staff of river basin organizations, regional organizations, and other stakeholders working on transboundary cooperation and water diplomacy are the target audience of the Checklist.





# Next steps related to the development of the checklist (2021)

- Focal points are invited to submit their written comments by 15 May
- Comments received will be addressed by the Drafting Group with the support of the secretariat and the publication will be finalized for adoption at the Meeting of the Parties at its 9<sup>th</sup> session
- Publication will be translated in French, Russian and Spanish



# Proposed future activities for 2022-2024 workplan

- The "Checklist on the development of agreements and arrangements for transboundary water cooperation" will be **further developed into an online toolkit**, with good practices collected, links to agreements, etc.
- Two regional or basin workshops on developing agreements and establishing joint bodies will be organized to support cooperation processes, promoting the "Checklist on the development of legal frameworks for transboundary water cooperation" and the "Principles for Effective Joint Bodies for Transboundary Water Cooperation"



## Proposed future activities for 2022-2024 workplan

- Upon request from the concerned countries and pending the availability of resources, a number of basin-level projects supporting the development of agreements and strengthening of institutions will be implemented. Possible river basins for the implementation of such projects include the Bug, Chu Talas, Dniester, Drin, Euphrates and Tigris, Kura, Mejerda, Mono, Neman and Ogooué-Ntem-Nyanga-Komo, as well as the Senegalese-Mauritanian aquifer.
- Activities will also include support to regional cooperation, such as work on dam safety and water quality in Central Asia, support to regional economic communities in Africa and in Latin America for the development of regional frameworks for water cooperation.
