
Summary

This document provides an overview of capacity-building and technical assistance activities carried out under the ECE subprogramme on trade during the period May 2019–April 2021. It includes activities carried by the secretariat under the Steering Committee on Trade Capacity and Standards as well as by the Working Party on Regulatory Cooperation and Standardization Policies (WP.6); Working Party on Agricultural Quality Standards (WP.7); the United Nations Centre for Trade Facilitation and Electronic Business (UN/CEFACT) and the Regional Adviser. Since April 2020, a particular focus on ECE support to member States' efforts has been placed on supporting a resilient, inclusive, sustainable post COVID recovery.

Sections covering activities by UN/CEFACT are for information only.

This report is presented to the Steering Committee on Trade Capacity and Standards for decision.

I. Introduction

- 1. The United Nations Economic Commission for Europe (UNECE) Trade subprogramme supports trade and economic cooperation among ECE member States and facilitates their integration into global value chains, drawing on the work of its intergovernmental bodies and expert groups. The subprogramme contributes to ensuring:
- (a) A predictable, transparent and harmonized regulatory environment for commerce and business through strengthening the convergence of regulations, promoting international standards and developing best practices in areas of regulatory cooperation, conformity assessment and market surveillance.
- (b) Sustainable trade in agricultural produce, integration into international supply chains and food loss reduction through the development of agricultural quality standards and related international best practice for implementation and use by regulatory authorities as well as the private sector.
- (c) Simple, transparent and effective processes for global commerce through the development and maintenance of international trade facilitation instruments including global standards and best practices for moving from paper-based to automated electronic environments and for the harmonization and simplification of the business processes underpinning export and import activities.
- 2. Technical assistance and capacity-building activities are demand-driven and delivered in close cooperation with development partners. The activities aim at supporting ECE member States, especially less economically developed and landlocked countries, in their efforts to implement ECE trade-related standards, recommendations and best practice guides. The activities also seek to support the removal of regulatory and procedural barriers to trade caused by capacity shortfalls and differences in administrative procedures, regulations and standardization policies.
- 3. The next section provides an overview of the Trade subprogramme's capacity-building and technical assistance activities for the period May 2019–April 2021, highlighting the main objectives, results achieved, and development partners. Section three lists the activities carried out by the Trade subprogramme's Regional Adviser.

To strengthen national capacities for using international best practices, tools and instruments as well as developing integrated strategies for facilitating crossborder agri-food trade, back-to-back with regular intergovernmental meetings. This work is part of existing multilateral mechanisms to define export requirements and improve the understanding of national stakeholders from target countries of the link between international standards, best practices, and quality production and for the increase of sustainable agricultural food supply. It also serves as a cost-efficient way to enhance the interregional dialogue, with importing countries and particularly the private sector.

UNECE organized three international expert workshops back-to-back with regular intergovernmental meetings in Geneva, Switzerland in May and June and in Potsdam in August 2019 (TFA Art.2.3). The latter focused on the sustainability of national production and consumption patterns in North-South and South-South meat trade as well as meat quality for a sustainable future. Over 55 participants were trained on sustainable livestock, food loss and waste prevention, eating quality, standards and innovative solutions for meat trade. At the Geneva events, 11 experts were trained in the development and implementation of international best practice for food quality and food loss prevention. Since the inception of this project, experts from Central Asia have developed the first quality standard for dried melons, at international level and within an intergovernmental body (adopted in November 2019). This is expected to increase the quality and export readiness of this Central Asian produce to world markets. In 2019, the total participation of experts from Central Asia in ECE regular meetings increased from 16 in 2018 to 21 in 2019. The contributions from the Central Asian region extended to many new and on-going work areas. In the Central Asian region, this resulted in the development of a multitude of training material and over 30 local training courses led by experts trained by this project. 12. Enhancing Traceability and Transparency for Sustainable Value Chains in Garment and Footwear (June 2019-June 2022).

Improving transparency and traceability is a priority for the garment and footwear industry to increase its ability to manage the value chains more effectively, identify and address labour and human rights violations, health and safety and environmental impacts to handle operational and reputational risks, while embracing more sustainable production and consumption patterns in line with the 2030 Agenda, specifically SDGs 8, 12 and 17. The project aims at providing the tools to take risk-informed decisions, build robust sustainability claims and to operate along a set of internationally agreed practices, thereby increasing visibility and accountability throughout the entire value chain.

This project created a multi-stakeholder policy dialogue platform engaging with more than 200 UN/CEFACT experts representing over 190,000 companies in more than 30 countries, which have been Partnerships. consulted to produce a toolbox to advance transparency and traceability. At the twenty-seventh UN/CEFACT Plenary UNECE Member States embraced a series of policy recommendations, implementation guidelines and an information exchange standard that together make it possible to assert and verify sustainability claims in the highly globalized garment and footwear sector. The project also launches a call to action, inviting Governments and industry actors to apply this toolkit of measures and take a positive step towards improving the environmental and ethical credentials of the sector. The traceability framework is testing the enabling role of advanced technologies, such as blockchain and DNA markers to support traceability and due diligence for the main textile fibres and materials value chains (cotton, leather, synthetic).

III. Regional Adviser's capacity-building and technical assistance activities during the period May 2019–April 2021

4. Based on the mandate of UNECE to support integration in the UNECE region and set standards for trade facilitation and e-business, the Regional Adviser assists economies in transition¹ to facilitate and develop their trade through the implementation of trade facilitation standards, recommendations and other tools, as well as support them in building subregional cooperation and integration, notably to strengthen their capacity for economic development and to achieve SDGs. In 2019 and 2020, the Regional Adviser's work focused on three areas: (1) assist transition economies in the implementation of the WTO TFA, contributing to SDG 17.10: promotion of a universal, rules-based trading system; (2) promote the implementation of UNECE trade facilitation standards, recommendations, and reference data models (RDMs); and (3) support the United Nations Special Programme for the Economies of Central Asia (SPECA). On this basis, the Regional Adviser has continued to manage projects and activities supporting countries in the implementation of UNECE and UN/CEFACT trade facilitation recommendations and standards and assisting them build subregional cooperation for the achievement of SDGs.

Capacity-building report of the Regional Adviser for 2020

I. Introduction

- 1. The Regional Advisor's work is based on the mandate of the United Nations Economic Commission for Europe (UNECE) and the United Nations Centre for Trade Facilitation and Electronic Business (UN/CEFACT) to set standards for trade facilitation and e-business. It aims at improving cooperation and integration in the UNECE region and achieving the Sustainable Development Goals (SDGs). The Regional Advisor helps the seventeen UNECE programme countries to facilitate and develop their trade capacity by implementing UN/CEFACT standards and trade facilitation recommendations. In 2020–2021, during the COVID-19 pandemic, the Regional Advisor's work included two areas related to UN/CEFACT:
 - Thirteen transition economies received assistance to implement measures of the World Trade Organization (WTO) Trade Facilitation Agreement (TFA), in which UNECE and UN/CEFACT have a comparative advantage (WTO articles 10.1, 10.3, 10.4, and 23.2) due to their normative instruments. This is reflected in the improved categorization of measures in the countries' notifications to WTO.⁵ The Regional Advisor thus contributed to the achievement of SDG 17.10. Specifically, he provided support to the countries participating in the United Nations Special Programme for the Economies of Central Asia (SPECA)⁶ to implement the Ashgabat Initiative on Reducing barriers to trade and transport;⁷ the SPECA Trade Facilitation Strategy;⁸ and to limiting the negative effects of non-tariff barriers to trade in times of pandemic.
 - The activities of the Regional Advisor boosted the implementation of UN/CEFACT semantic standards and reference data models, notably to limit the effects of the COVID-19 pandemic on connectivity, trade, and transport.
- 2. In this sense, the Regional Advisor continued to manage projects and activities supporting countries in the implementation of the UNECE and UN/CEFACT trade facilitation recommendations and standards.

The UNECE advisory services helped Kazakhstan and Ukraine, as well as Azerbaijan, Belarus and Uzbekistan (three WTO accession countries) assess their readiness and plan the implementation of the TFA measures. All seventeen programme countries received assistance for implementing the TFA measures in which UNECE has competitive advantage (notably art. 23.2, 10,1, 10.3, and 10.4). Kazakhstan, for example, notified to the WTO Secretariat improvement in the implementation in July-August 2019: it moved three measures, on which there had been collaboration with the Regional Advisor (enquiry points, use of international standards and Single Window) from category C to category B and clarified that practically all measures will be fulfilled by 22 February 2022. On 15 July and 3 December 2020, Kyrgyzstan notified with information on the implementation of several measures, for some of which they received assistance from UNECE. On 7 July 2020, Tajikistan notified of ministries and agencies responsible for the implementation of most TFA measures, as well as progress in the implementation of four measures, including the Single Window, on which they have received assistance from UNECE. Unfortunately, Afghanistan notified in May 2020 regress in its readiness to implement three Customs-related measures, yet UNECE has little leverage to affect that development.

- 3. Activities of the Regional Advisor during the last years have contributed to two major developments in 2020:
 - Activities in support of Turkmenistan since 2016 helped the country obtain in July 2020 observer status with WTO (a step towards achieving SDG 17.10); and
 - On 28 October 2020 the European Commissioners agreed on a new proposal for European Union single window legislation. The UNECE Regional Advisor had contributed for two years to the drafting of this legislation upon invitation by the Directorate General Taxation and Customs Union (DG TAXUD).

II. Assisting the transition economies with trade facilitation and implementing TFA

- 4. Two training events organized by the Regional Advisor, in cooperation with the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) and other partners, boosted the capacity of 210 experts from the SPECA countries (Afghanistan, Azerbaijan, Kazakhstan, Kyrgyzstan, Tajikistan, Turkmenistan, and Uzbekistan) to implement trade facilitation. First, a training event, originally planned to be held in Dushanbe, was held online on 6–7 July 2020. This event was organized with Tajikistan, the Organization for Security and Cooperation in Europe (OSCE) and GIZ. It encouraged the establishment of national trade facilitation committees (NTFCs) in the SPECA countries, notably in Azerbaijan (which requested and received further assistance from the Regional Advisor) and Uzbekistan. It started work on harmonizing border-crossing procedures under the SPECA Working Group on Trade. Second, a seminar on 3–4 November 2020 for NTFCs in the SPECA subregion laid the foundations for regional cooperation of NTFCs and produced a list of recommendations for action.
- 5. Two working papers of the SPECA Working Group on Trade were drafted and published in 2020. Respective agencies in the SPECA countries currently continue to review the two papers, including their recommendations, with a view to providing a revised version for the next meeting of the Working Group. The first is a working paper on harmonizing border-crossing procedures in the SPECA countries, ¹¹ which contains recommendations for action to the SPECA countries. The second is a study on the impact of COVID-19-induced non-tariff measures (NTMs). ¹² It provides guidance to countries on how to prevent NTMs imposed due to the pandemic from becoming barriers to trade.
- 6. In 2020, upon request from the Government of Uzbekistan, the Regional Advisor started a project on self-assessment of readiness of Uzbekistan to implement WTO TFA with two seminars and an internal survey. The project will finish later in 2021 and is expected to help with the accession of Uzbekistan to WTO and with the achievement of SDG 17.10.

III. Data sharing in the age of COVID-19

7. The Regional Advisor took up new tasks in the rapid response to the challenges of COVID-19, notably managing a segment of the United Nations Development Account (UNDA) project "Transport and Trade Connectivity in the Age of Pandemic: United Nations solutions for contactless, seamless and collaborative transport and trade". ¹³ The segment led by the UNECE Economic Cooperation and Trade Division (ECTD) has the following deliverables:

- A Guide for National Trade Facilitation Bodies on How to Use UN/CEFACT Standards and Tools¹⁴ in the age of COVID-19 is published and intended for distribution among National Trade Facilitation Bodies (NTFBs) in 2021;
- Experts working under the UNDA COVID-19 project developed a package of standards for electronic document equivalents accompanying goods in multimodal transport. The Regional Advisor contributed to the advancement and rollout of this package. Under this project the following activities have taken (or continue to take) place:
 - Experts developed new standards for eight new logistics and other documents (including multimodal waybill, packing list and other documents) to advance pilot implementation;
 - They continue filling in gaps in the package of standards for documents accompanying goods transported by different modes of transport. By February 2021, these include the following: maritime waybill; inland water transport documents; 15 railway consignment notes; 16 invoice for customs; and Certificate of Origin; 17
 - Experts from Belarus and Ukraine have started implementing existing UN/CEFACT standards for electronic transport document equivalents¹⁸ notably for the electronic road consignment note (eCMR) under the Convention on the Contract for the International Carriage of Goods by Road (CMR). Experts are also working on the possible use of the eCERT standard to implement electronic phytosanitary certificates in Belarus and Ukraine;
 - The Regional Advisor has engaged with the International Civil Aviation Organization (ICAO) for further cooperation in the area of data and document exchange for cargo transport by air; and
 - The first pilot implementation cases involve (1) the development of an electronic version of the Bill of Lading of the International Federation of Freight Forwarders' Associations (FIATA), aligned with the UN/CEFACT reference data models, and (2) contributions to the Black Sea/Baltic Sea digital corridor and a Dnieper/Danube pilot implementation.
- Activities on data sharing and alignment with the Multi-Modal Transport Reference Data Model (MMT-RDM) have taken place:
 - At the Tenth International Seminar on Trade and Transport Facilitation: Multimodal Transport Data Exchange, Digital Transport Corridors, and Trade Facilitation, ¹⁹ organized by UNECE (27–29 April 2020), business community and government representatives from Belarus, Lithuania and Ukraine demonstrated interest in working on multimodal data exchange in the Black Sea/Baltic Sea corridor and starting a pilot implementation. The seminar issued policy recommendations to that effect. It initiated collaboration with FIATA, freight forwarders in Ukraine, and UN/CEFACT experts, to develop an electronic equivalent of the FIATA multimodal Bill of Lading aligned with the UN/CEFACT standards;

- At the brainstorming session on data harmonization and modelling using UN/CEFACT standards,²⁰ organized by UNECE and the Eurasian Economic Commission (EEC) on 18 June 2020, experts from UNECE, EEC, and UN/CEFACT agreed to cooperate and use the window of opportunity created by COVID-19 to harmonize standards for data exchange; and
- At the regional seminar for the Western Balkans on data sharing and single window implementation²¹ (27–28 October 2020) experts from UNECE, UN/CEFACT, the Western Balkan countries' single window projects, the World Bank, the Central European Free Trade Agreement (CEFTA) and others issued a set of recommendations on how to use UN/CEFACT semantic standards and reference data models in their single window projects.
- 8. Work on the UNDA COVID-19 project has strengthened collaboration with the European Commission, EEC, railway, air, and other sectorial organizations to advance the digitalization of multimodal transport data and document exchange with reference to the UN/CEFACT standards. Letters from the European Commission²² and ICAO²³ attest to their support for this initiative and for the UNDA COVID-19 project.
- 9. Due to restrictions caused by COVID-19, capacity-building seminars and subregional cooperation events have taken place online, and this will be the case for the foreseeable future. Information sessions on the objectives and results of the UNDA COVID-19 project will take place for the UNECE Sustainable Transport Division, the five United Nations Regional Commissions and the United Nations Conference on Trade and Development (UNCTAD) which are the agencies participating in the UNDA COVID-19 connectivity project as well as the European Commission and other partners.
