1. Paragraph 4

At the end of paragraph 4, add a bullet point

 A new testable rule R017 applied on message I5 which would read as follows: "Customs authorities can only query TIR transport information related to a guarantee if they are part of the itinerary.";

2. Paragraph 6

After paragraph 5, insert a new paragraph reading

5bis. The "Container transport indicator" used in class "Consignment" is not an actual indicator but rather a coded attribute linked to code list UN/EDIFACT 7365 (Processing indicator description code). Consequently, condition C005 need to be amended and test for value "69", which means "Goods not carried in container" instead of "FALSE". Conditions C005 should therefore read as follows:

IF (CONSIGNMENT.Heavy or bulky goods indicator) = FALSE AND (CONSIGNMENT. Container transport indicator) = 69
THEN NOT EMPTY (TRANSPORTEQUIPMENT.CERTIFICATEOFAPPROVAL)
ELSE EMPTY (TRANSPORTEQUIPMENT.CERTIFICATEOFAPPROVAL)
