

- 18. The Joint Working Party is invited to:
- (a) Advise the Joint Section on the content of the planned series of studies on circularity concepts in forest-based industries, as presented by the secretariat.
- (b) Advise the Joint Section if the draft generic definition of a circular economy suggested by the Taskforce on Measuring Circular Economy requires modification, and terms used additional clarification.
- (c) Provide the Joint Section with guidance on the presented draft definition of a circular economy in the forest sector.
- (d) Inform the Joint Section about member States' priorities and needs in application of circular models in the forest sector and the tools that ECE and FAO could develop to support them.

I. Forest Resources

D. Key points on forest resources for guidance and discussion

- 21. The Joint Working Party is invited to:
- (a) Take note of the data collection processes for global and regional reporting, comment on the implementation of the 2020 cycle and make recommendations for future work in this area;
- (b) Take note of the tools developed for sharing forest sector related information, such as the FAO FRA data platform, the Joint ECE/FAO/Forest Europe pan-European database, the ECE/FAO INForest knowledge platform and the ECE Statistical Database, and provide advice on possible follow-up;
- (c) Actively engage in the discussion and provide input and feedback to the ongoing project on reporting and assessment of forest damage and disturbance in the ECE region;
- (d) Review the work of the Team of Specialists on Monitoring Sustainable Forest Management and make recommendations for its work.

II. Forest products production, trade, and consumption

C. Key points on forest products data collection for guidance and discussion

- 45. The Working Party is invited to:
- (a) Provide guidance to the secretariat on which source of trade data to give preference when processing the Joint Forest Sector Questionnaire (JFSQ);
- (b) Comment on the list of proposals for the Harmonized System of the World Customs Organization revision for 2027;
 - (c) Propose revisions to the JFSQ for 2023;
- (d) Comment on the deadlines for the JFSQ and the Timber Forecast Questionnaire (TFQ) and the data processing and exchanges planned for 2022;
- (e) Comment on the outcome of the discussions on Statistical Data and Metadata eXchange.

F. Key questions on market assessment for guidance and discussion

- 60. The Joint Working Party is invited to:
- (a) Provide feedback on the improvements of the Review proposed by the Team of Specialists on Sustainable Forest Products and discuss possible ways forward;

- (b) Discuss whether to phase out printed versions of the Forest Products Annual Market Review (FPAMR) and, in the future, move to exclusively online, machine readable versions;
- (c) Consider a longer-term perspective to produce the FPAMR through a sound financial basis for expert contributions to the various chapters;
 - (d) Advise the secretariat on how to best discuss forest products markets in 2022.

D. Key points on wood energy data assessment for guidance and discussion

- 67. Delegates are invited to:
- (a) Provide feedback on the data collection process with the Joint Wood Energy Enquiry;
- (b) Advise how to improve the wood energy database, the display of data and its dissemination;
 - (c) Consider hosting a capacity building event on wood energy data collection;
- (d) Provide guidance on further cross-sectoral cooperation on wood energy matters by the secretariat.
