## **Draft Programme of Work of the Statistics subprogramme** for 2023

#### **Prepared by the Secretariat**

#### Summary

The draft Programme of Work of the UNECE Statistics subprogramme follows the template, as approved by the Executive Committee and further updated in line with the annual budget format, introduced in 2020 in line with General Assembly resolution 72/266, with enrichments reflecting General Assembly resolutions 74/251, 75/243 and 76/245.

The text is an excerpt from the ECE proposed programme budget for 2023 (A/77/6 (Sect.20), which was reviewed by the ECE Executive Committee in December 2021. The Programme of Work informs about the status of results planned in Programmes of Work for 2021 and 2022 (results 1 and 2), and presents a new result expected in 2023 'Increased number of countries collaborating on developing and using Machine Learning techniques for the production of official statistics' (result 3).

The draft Programme of Work for 2023 is submitted to the Conference of European Statisticians for adoption and for recommending it to the Executive Committee of the United Nations Economic Commission for Europe for approval.





#### I. Introduction

- 1. The present document sets out the draft programme of work of the Statistics subprogramme ("the subprogramme") for 2023. The Conference of European Statisticians is invited to adopt it and recommend to the Executive Committee (EXCOM) for approval. Any subsequent additional, discontinued or carried over deliverables will be reflected in UN Umoja system used by the Secretariat for planning, monitoring and reporting on the implementation of the programme.
- 2. The draft programme of work applies a results-based management (RBM) approach, a broad management approach which establishes logical relationship between the hierarchical results (deliverables results objectives impact) known as 'results chain', the resources (human and financial) known as 'inputs' and the external factors (strategic, governance, operational, financial) which can prevent from achieving the objective.
- 3. The objective, the strategy, the planned results and the deliverables in the draft programme of work correspond to those contained in the ECE proposed programme budget for 2023 (A/77/6 (Sect.20)). The work of the subprogramme is aligned with the Sustainable Development Goals (SDGs). In attaining its objective, the subprogramme builds on cross-sectoral collaboration with other subprogrammes in relevant ECE cross-sectoral collaboration areas where multiple SDGs converge<sup>1</sup>. This type of collaboration enables the subprogramme to maximize existing synergies, increase the efficiency of its work and have a multiplying effect on the impact of its actions to support countries to implement SDGs. The deliverables of the subprogramme fall into the following main categories: (a) facilitation of the intergovernmental process and expert bodies; (b) generation and transfer of knowledge, including technical cooperation projects, training events, seminars, workshops, and publications; (c) other substantive deliverables, and (d) communication deliverables.
- 4. The details of the proposed publications are provided in Annex I. The overall ECE legislative mandates and those specific for the subprogramme are listed in Annex II.

### II. Objective

5. The objective, to which this subprogramme contributes, is to advance official statistics at the national and international levels for evidence-based policymaking and assessing progress towards achieving the SDGs and to ensure the coordination of statistical activities in the ECE region under the Conference of European Statisticians.

## III. Strategy

- 6. The strategy of the subprogramme is guided by the priorities and needs of member States and is based on the core interlinked functions: the streamlining of international statistical work in the ECE region through policy dialogue; methodological work to develop and promote guidelines and recommendations to enhance the quality of statistics; and statistical capacity development of ECE member States with less developed statistical systems.
- 7. To contribute to the objective, the subprogramme will:
- (a) Promote in-depth statistical dialogue at the Conference of European Statisticians and expert meetings;
- (b) Launch regional and country-specific initiatives related to methodological work to develop and disseminate statistical models, guidelines and recommendations to enhance the quality of statistics, and to promote the use of official statistics;

- (c) Maintain and develop the ECE statistical database;
- (d) Establish and strengthen partnerships between geospatial experts and statisticians to support the integration of statistical and geospatial information, in cooperation with statistical departments of other regional entities such as Eurostat, OECD, the European Free Trade Association, the Interstate Statistical Committee of the Commonwealth of Independent States and the Eurasian Economic Commission, as well as international specialized agencies active in the region;
- (e) Facilitate the exchange of experiences and good practices in the field of population and housing censuses, price statistics and environment statistics, including adaptation owing to COVID-19 restrictions; and
- (f) Provide support to countries in planning and conducting their census and developing their statistical capacity, including cross-cutting topics such as statistics for SDGs, statistical legislation, data collection, data integration, dissemination and human resource management.
- 8. The above-mentioned work is expected to result in:
- (a) Member States have improved statistical methodology and capacity to measure and monitor the SDGs;
- (b) Member States conducted the census through innovative and efficient approaches, including through improved cost-efficiency, coverage, accuracy, comparability and timeliness of dissemination of the census results;
- (c) Member States have improved capacity to provide the statistics necessary to develop evidence-based policies to manage their post-pandemic recovery.


#### IV. Planned results for 2023

## A. Result 1: Conducting a new population and housing census that provides cost-effective and better-quality results

#### Programme performance in 2021 and target for 2023

9. The subprogramme's work contributed to the completion of population and housing censuses in 77 per cent of ECE member States by 2021, which did not meet the planned target of 84 per cent. The target was not met because some countries in the region postponed their census due to the pandemic. The progress towards the objective and the target for 2023 are presented in the performance measure below (see Figure 1).

Performance measure: Economic Commission for Europe countries having conducted a census in compliance with the Conference of European Statisticians recommendations (Cumulative percentage)




#### B. Result 2: Increasing the number of countries that report sexdisaggregated statistical indicators

#### Programme performance in 2021 and target for 2023

10. The subprogramme's work contributed to the increase to 65 percent of sex-disaggregated indicators available for ECE member States in the Sustainable Development Goals database, which met the planned target of 65 percent. The progress towards the objective and the target for 2023 are presented in the performance measure below (see Figure 2).

# C. Result 3: Increased number of countries collaborating on developing and using Machine Learning techniques for the production of official statistics (new result for 2023)

#### Proposed programme plan for 2023


11. Monitoring the SDGs and other internationally agreed development goals require more indicators that are further disaggregated, for example, by gender statistics or disability status, and are produced more frequently. Countries do not always have sufficient resources nor consistent data sources to produce statistics needed to report adequately on progress on the SDGs or to better respond to the COVID-19 pandemic and other crises. A large part of data collected has to be manually classified and coded. Machine Learning (ML) can help automatize this process, allowing the use of new data sources, when manual processing is not feasible. As the subprogramme promotes the use of advanced methodologies for modernising the statistical production, it had piloted a global project to investigate how ML can be used in producing official statistics, leading to several national statistical offices (NSOs) starting to use ML techniques.

#### Lessons learned and planned change

- 12. The lesson for the subprogramme was that there was a strong need for further developing and implementing ML techniques in producing official statistics, in order to ensure that best practices on the use of ML can be scaled up. It will enable NSOs to produce higher volumes of more disaggregated statistics with a higher frequency, allowing for better monitoring of progress towards SDGs.
- 13. In response, the subprogramme will setup and support a community platform and environment where NSOs will share knowledge and experiences and collaborate on further developing common solutions on the use of ML techniques. Pilot studies in several areas and for different types of application of ML will be setup and ways to transfer knowledge will be established. Results and experiences as well as algorithms and methodologies developed publicly will be shared through online platforms, online seminars and other events. The

expected progress towards the objective is presented in the performance measure below (see Figure 3).
