The Meeting of the Parties to the Convention on Access to Information, Public Participation in Decision-making and Access to Justice in Environmental Matters (Aarhus Convention) will hold its third extraordinary session from 23 to 24 June 2022, in Geneva.

The third extraordinary session of the Meeting of the Parties is convened in accordance with decision VII/9 on a rapid response mechanism to deal with cases related to article 3 (8) of the Convention on Access to Information, Public Participation in Decision-making and Access to Justice in Environmental Matters (ECE/MP.PP/2021/2/Add.1), adopted by the Meeting of the Parties at its seventh ordinary session (Geneva, 18–21 October 2021), at which it was decided to hold an extraordinary session in 2022 in order to elect an independent Special Rapporteur on environmental defenders.<sup>1</sup>

The Meeting of the Parties will be invited to discuss the main trends, challenges and good practices with regard to the protection of environmental defenders. The discussion will be organized in a format of keynote statements and interventions by the representatives of Governments, non-governmental and intergovernmental organizations and other stakeholders, followed by a general discussion. The topics for discussion will be based on decision VII/9 and the key issues addressed through the work of the Task Forces and Working Group of the Parties.
