





CONTRIBUTION TO PEACE AND STABILITY: FRAMEWORK AGREEMENT FOR THE SAVA RIVER BASIN – FASRB (2002; 2005)

- signed in Kranjska Gora, Slovenia, in December 2002,
- parties: Slovenia, Croatia, Bosnia and Herezgovina, Serbia
- the first development-oriented multilateral agreement in the region signed after the Agreement on Succession,

Key objective:

transboundary cooperation for sustainable development of the region


Particular objectives:

- establishment of international regime of navigation,
- ensuring sustainable water management, and
- prevention or limitation of hazards (floods, droughts, accidents, etc.)

THE THREE PILLARS OF SAVA RIVER IWRM

Sava River Basin Management Plan (2014, 2022)


- objective: to achieve 'good status' of all waters and prevent its deterioration (EU WFD 60/2000/EC)
- 1st Sava RBMP adopted at the 5th MoP in 2014
- 2nd Sava RBMP to be approved at 9th MoP in November 2022

Sava Flood Risk Management Plan (2019)

- objective: to establish joint objectives of flood risk management (EU Flood Directive 2007/60/EC)
- 1st Sava FRMP adopted at the 8th MoP in 2019
- development of 2nd Sava FRMP ongoing, PFRA elaborated

Outline on Sediment Management Plan (2022)

- objective: to provide an analysis of existing sediment management practices and define further steps for a full-fledged SMP
- supported by the UNESCO, adopted by the ISRBC in March 15-16 2022



MAIN ACHIEVEMENTS

World Bank Sava – Drina River Corridor Integrated Development Programme

(2017)

- objective: to facilitate IWRM managment and development along the Sava and Drina river corridors
- based on ISRBC cross-sectorial Joint Action Plan for the Sava River Basin (2017)
- Estimated to 223 mio EUR
- two phases of process, planning period of 10 years

Sava Flood Forecasting and Warning systems (since 2018)

- established and maintained by the ISRBC and Sava Countries
- fully operational flood forecasting platform which integrates existing hydrometeorological data and models as a support to the regular warning dissemination

Joint Sava River Systems of DATA Exchange

- Accident Emergency and Warning System (ICPDR, 1997)
- Sava GIS (2015)
- Sava HIS (2015)

UNECE WATER CONVENTION CONTRIBUTIONS AND COOPERATION WITH ISRBC

- Assistance, values and principles incorporated in the establishment of the ISRBC
- UNECE Water Convention activites: meetings, workshops, conferences, direct contact and collaboration
- UNECE Water Convention publications

Water-Food-Energy-Ecosystems Nexus in the Sava and Drina River Basins (2016)

- supported by the UNECE
- objective: to foster transboundary cooperation by identifying intersectoral synergies and determing measures for compensation of tensions due to multiple needs of riparian countries for water resources
- sectors included: water management, agriculture and energy

Outline of the Climate Adaptation Strategy and basin-wide priority measures for the

Sava River Basin (2018)

- supported by the French Ministry of Ecological and Inclusive Transition and the UNECE
- objective: to identify priority basin-wide measures, to suggest modalities and to assess cost estimates for a full scale CCA


BENEFITS AND LESSINS LEARNED

Benefits of the FASRB and ISRBC activites

- improved transboundary cooperation in the international Sava river basin
- increased level of mutual trust among the involved countries
- enhancement of cross-sectoral cooperation on national and international levels
- preparation and implementation of transbondary and international projects of common interest
- enhancement of stakeholders involvement (stakeholder forums, Sava Youth Parliament)

Lessons learned in transboundary water cooperation

- sound legal framework (FASRB, Protocols) are required
- solid institutional framework (IRBO ISRBC) and institutional capacity is required
- common transboundary water governance approach is required
- commitments on diverse levels (political, governance, policy, expert level)
- the way passed as well as the way to go is a demanding, but beneficial process
