WCO in brief



- **WCO**, established in 1952 as CCC
 - ✓ 184 Customs administrations, 98 of world trade
 - ✓ Only international organization with competence in Customs matters as the global centre of Customs expertise

- **Slogan of 2022**, "Scaling up Customs Digital Transformation by Embracing a Data Culture and Building a data Ecosystem"
 - ✓ Fully digital environment from across the trade ecosystem
 - ✓ Establishing formal data governance, making use of the standards, providing appropriate management of data, adopting progressive approaches, etc.
 - ✓ WCO working groups' agenda, seminar, e-learning, capacity building framework, publication, and BACUDA

WCO Activities related to transport



➤ WCO Railway Guidance

- ✓ Discussions on Customs-Railway Cooperation since 2017
- ✓ WCO Railway Project in 2019: Online Survey, Field Studies, Global Railway Workshop, Railway Guidance, Regional Capacity Building Workshops
- ✓ The Railway Guidance aims to:
 - Promote electronic Customs procedures in railway transportation
 - Simplify and harmonize Customs regulations and legislations
 - Enhance Customs procedures/controls to be globally applied
 - Encourage the use of advanced technology, e.g. NII and electronic seals
 - Strengthen cooperation between G2G, G2B etc.
- ✓ 6 Area of The Railway Guidance: (1) Electronic Customs transit procedures, (2) Customs control in railway transportation, (3) Railway postal procedures, (4) Passenger Control, (5) Cooperation with private sector, governmental agencies, (6) Cooperation among Customs administrations

WCO Activities related to transport



➤ Istanbul Convention: Electronic Carnet System

- ✓ Provides simplified process for temporary admission of goods, including means of transport
- ✓ Operation of ATA Carnet and CPD Carnet, administered by ICC and FIA
- ✓ eCPD Distribution System, developed by FIA
 - Secure and web-based distribution system using QR codes
 - First eCPD has issued in May 2021
 - Currently hybrid, to go fully digital in the future
- ✓ eATA Carnet System, developed by ICC
 - Joint ATA/Istanbul Administrative Committee has worked on the development of a centralized electronic ATA Carnet System
 - eATA Carnet Pilot Project, launched in 2019
 - Production period is expected to start from 2023
 - eATA Carnet System, with 5 components (ATA Carnet Core, ATA Carnet Proxy, ATA Carnet Customs, ATA Carnet NICS, ATA Carnet APP) will contribute to a more efficient and secured trading environment
