Proposal for amending the annexes I and II of the European Agreement on Important International Combined Transport Lines and Related Installations

Submitted by Lithuania

I. Background/explanation

Lithuania, as a Contracting Party to the European Agreement on Important International Combined Transport Lines and Related Installations (AGTC), proposes amendments to Annexes I and II of the AGTC due to various developments and changes in the territory of Lithuania as well as to correct certain inconsistencies in points of references, as provided in point II below.

II. Proposed amendment

Annex I

Railway lines of importance for international combined transport:

Under (34) Lithuania:

To update lines C-E 75 and C 20/3 as follows:

C–E 75 (Trakiszki [Trakiškė]–) Mockava–Šeštokai–Kazlų Rūda–Kaunas (Palemonas)–Radviliškis–Šiauliai–Joniškis (–Meitene)

Contracting Parties concerned: Latvia, Lithuania and Poland

C 20/3 (Nesterov[Nesterovas]–)Kybartai–Kazlų Rūda–Kaunas

Klaipėda–Šiauliai–Radviliškis Kaišiadorys–Vilnius (Vaidotai)–Kena (–Gudagai)

Contracting Parties concerned: Germany, Belarus and Lithuania

Under (43) Latvia:

To update line C-E 75 as follows:

C–E 75 (Valga–) Lugaži–Riga–Jelgava–Meitene (–Joniškis)
