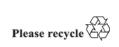

II. Annotations to the provisional agenda

1. The Chair of the United Nations Economic Commission for Europe (ECE) Steering Committee on Education for Sustainable Development will open the special session. The Committee will then be invited to adopt its agenda as set out in the present document (ECE/CEP/AC.13/S/2022/1).

2. Third High-level Meeting of Education and Environment Ministries

2. The Steering Committee will be updated on the process of preparation, expected outcomes and agenda of the Third High-level Meeting of Education and Environment Ministries, to be held in Nicosia, on 5 October 2022.

- 3. The Steering Committee will be updated on the official documents prepared for consideration at the Third High-level Meeting of Education and Environment Ministries, including the Framework for the implementation of the United Nations Economic Commission for Europe Strategy for Education for Sustainable Development from 2021 to 2030 (ECE/CEP/AC.13/2022/3) and the draft Ministerial Statement (ECE/CEP/AC.13/2022/7) of the Third High-level Meeting of Education and Environment Ministries to be held in Nicosia on 5 October 2022 in the framework of the Ninth Environment for Europe Ministerial Conference (Nicosia, 5–7 October 2022).
- 4. The Chair will brief the Steering Committee on the process of drafting the Framework and the Ministerial Statement to be adopted at the High-level Meeting. The Steering Committee considered the draft Ministerial Statement at its seventeenth meeting (Geneva, 30–31 May 2022). After the deadline for possible comments of 20 June 2022 had passed, the draft Ministerial Statement was submitted to the Third High-level Meeting of Education and Environment Ministries in the framework of the Ninth Environment for Europe Ministerial Conference.
