

1. Adoption of the Provisional Agenda

The first item to be considered is the adoption of the draft agenda.

2. Towards Unified Railway Law in the Pan-European Region and on Euro-Asian Transport Corridors

The Working Party may wish to recall that at its seventy-fifth session, delegates discussed the conclusion of the mandate of the Group of Experts on Unified Railway Law. At this meeting, the Working Party agreed to further consultation within the framework of SC.2 and the Chair initiated a written consultation on this in May 2022. A summary of these consultations is included in document ECE/TRANS/SC.2/2022/3. Based on this, a special session of SC.2 was held on 7 September 2022 to discuss the outcomes of these written consultations. Document ECE/TRANS/SC.2/2022/3 also provides a summary of these discussions.

The Working Party may wish to discuss this document further.

3. Workshop: "The impact of climate change on the railways: how to protect, adapt and mitigate"

The Working Party may wish to consider the workshop on "The impact of climate change on the railways: how to protect, adapt and mitigate". Recent extreme weather events have shown

how vulnerable transport infrastructure is to climate change. While causing significant disruption to the functioning of this infrastructure and services, these events have also put the travelling public at danger. The aim of this workshop is to discuss the impacts that these events are having on the railways. Participants will also be invited to share good practice in how to minimise disruption and reduce safety risks resulting from extreme weather, as well as identify technological developments and procedural innovations to mitigate the harmful effects on the railways.

4. Terms of Reference and Rules of Procedure

The Working Party will be informed about the endorsement of the new Terms of Reference of the Inland Transport Committee (ITC) by The UN Economic and Social Council (ECOSOC) on 16 February 2022 (E/RES/2022/2) and the subsequent entry into force of the ITC Rules of Procedure as contained in ECE/TRANS/294, annex III. The ITC has asked that Working Parties consider adopting their own Rules of Procedure to be in line with those of ITC. The Working Party may wish to discuss document ECE/TRANS/SC.2/2022/1 which sets out the proposed Rules of Procedure for the Working Party on Rail Transport, based on those of ITC, and document ECE/TRANS/SC.2/2022/2 which sets out the proposed, updated, Terms of Reference for the Working Party on Rail Transport to incorporate direct reference to the proposed Rules of Procedure.

The Working Party may wish to consider adopting these documents.

5. European Agreement on Main International Railway Lines

The Working Party may wish to be informed by the secretariat about its activities to increase the number of contracting parties to the European Agreement on Main International Railway Lines (AGC). Detailed information on the AGC, including the up-to-date and consolidated text of the agreement (ECE/TRANS/63/Rev.4),¹ a map of the AGC network, an inventory of compliance with AGC standards, information on the background, benefits and accession requirements for AGC (ECE/TRANS/SC.2/2020/2) and the relevant Depositary Notifications are available on the website of the Working Party.

The Working Party may also wish to be informed about the notification of changes to the AGC agreed at previous session of the Working Party (ECE/TRANS/SC.2/2021/2) and notified to the depository in New York as well as potential new amendments.

The Working Party will be updated on efforts being undertaken to update the joint AGC-AGTC online tool on technical parameters for operation on the E-Rail network.

6. The Permanent Identification of Railway Rolling Stock

The Working Party may wish to be updated about the work of Group of Experts on the Permanent Identification of Railway Rolling Stock that concluded its mandate in 2022. In concluding its mandate, the Group produced document ECE/TRANS/SC.2/2022/4 that set out a summary of its activities, ECE/TRANS/SC.2/2022/5 containing the proposed Model Rules for the Permanent Identification of Railway Rolling Stock, ECE/TRANS/SC.2/2022/6 containing the Terms of Reference for the proposed Revisions Committee of the Model Rules, and ECE/TRANS/SC.2/2022/7 containing an initial, non-binding, Guidance Note for the implementation of the Model Rules.

The Working Party may wish to review these documents and consider whether to adopt them as a key pillar in the implementation of the ITC Strategy to 2030.

The Working Party may wish to be updated on developments in 2022 related to the activities of the Group of Experts on International Passenger Railway Hubs as set out in document ECE/TRANS/SC.2/2022/8.

8. Euro-Asian Rail Transport

The Working Party may wish to recall that at its seventy-third session a workshop was held on: "Making rail freight more competitive and the coordinated development of the rail network with a focus on how to work together at the government and sectoral levels on EATL". Following the seventy-third session, a summary publication was prepared by the secretariat and is available on the Working Party's webpage.

The Working Party may wish to be informed about and discuss new developments on Euro-Asian rail transport corridors, its involvement in developing the Euro-Asian Transport Links (EATL) project, including the results of the recent meetings on EATL and the completion of the "Sustainable Inland Transport Connectivity Indicators".

Following the decision of the Working Party at its seventy-second session, the Working Party may wish to be informed about developments in the Eurasian Rail Alliance Index (ERAI).

9. Trans-European Railway Project

The Working Party will be informed by the project manager of the Trans-European Railway (TER) project about the activities of 2022: the concrete results, the plan for subsequent years and the efforts to increase the number of participating countries.

The Working Party may wish to review the results and consider how to further support and contribute to the TER project.

10. Railway Financing and Public-Private Partnerships

The Working Party may wish to be informed about developments in the ECE Guiding Principles for People-First Public-Private Partnerships for the United Nations Sustainable Development Goals as well as the role of public-private partnership projects being undertaken in the rail sector.

The Working Party may also wish to be informed about the development of public-private partnerships in railways that are financed by international financing institutions.

11. Rail Security

The Working Party may wish to be informed about developments in rail security, including updates on the Rail Security Observatory and the ongoing collaboration with the International Union of Railways (UIC) on security matters.

12. Innovation in Rail Transport

In line with the ECE road map for promoting the use of Intelligent Transport Systems (ITS) that contains 20 global actions for 2012–2020 ("Intelligent Transport Systems (ITS) for sustainable mobility", 2012). The Working Party continues work in this area.

The Working Party may wish to recall that it agreed to the creation of a rail innovation observatory aimed at sharing with member States best practice innovations that could further help develop the competitiveness of the railways. The aim would also be to assist in achieving the Sustainable Development Goals and work towards the achievement of the technology pillar of the ITC strategy. The Working Party may wish to be updated on the creation of the observatory.

13. Productivity in Rail Transport

The Working Party may wish to recall that, at its last session, it discussed the results of the data gathering process as set out in document ECE/TRANS/SC.2/2021/4. The Working Party may wish to discuss the data gathering process for 2023 based on desktop information available at UIC and ECE.

14. Climate Change and Rail Transport

The Working Party will be updated on the work of the Group of Experts on Climate Change Impacts and Adaptation for Transport Networks and Nodes, on climate change mitigation and the For Future Inland Transport Systems tool and on green logistics, eco-scoring and related matters.

15. Railway Reform and Review

The Working Party may wish to be informed about the developments on railway reform and developments in the sector, building on the workshop held at the seventy-first session of the Working Party.

16. Facilitation of International Rail Transport in the Pan-European Region

(a) Facilitation of Rail Border Crossings

The Working Party may wish to be informed about developments in annex 9 to the "Harmonization Convention" on facilitating rail border crossings in the pan-European region. The Working Party may also wish to discuss the results of the survey developed by the secretariats of SC.2 and of the Working Party on Customs Questions affecting Transport (WP.30) on annex 9 (ECE/TRANS/SC.2/2022/10).

Member States may also wish to share best practices in implementing the Harmonization Convention at the session.

(b) Harmonization of Technical Specifications on Different Railway Systems

The Working Party may wish to be informed by the Organization for Cooperation between Railways (OSJD) and/or the European Union Agency for Railways (ERA) about improvements in the 1,435 mm and the 1,520 mm broad gauge railway systems, and about the results of the work of the OSJD/ERA Working Group on Interoperability.

17. Rail Statistics

The Working Party may wish to be informed about the ongoing work in rail statistics and its relevance to the Working Party, in particular, about the work of the Working Party on Transport Statistics (WP.6).

18. Improving Safety in Rail Transport

The Working Party may wish to recall that at its seventy-second session, it had decided to widen the scope to safety at level crossings to cover all relevant areas of rail safety. The Working Party may wish to be informed about developments in this area.

In line with discussions at the seventy-third session of SC.2, the Working Party may also wish to discuss developments related to the Code of Practice on the Packing of Cargo Transport Units administered by the Working Party on Intermodal Transport and Logistics.

19. Activities of the Inland Transport Committee and its Subsidiary Bodies

The Working Party will be informed about activities of ITC, its Bureau, subsidiary bodies and other United Nations organizations on matters of interest to the Working Party. In particular, the Working Party will be informed about the request of the Chair of ITC to Working Parties on: the Adoption of the Terms of Reference of ITC (discussed in agenda item 4), the implementation of the ITC strategy, inputs into the Road Safety Action Plan, aspects related to intelligent transport systems (discussed under agenda item 12), and accelerating climate change mitigation efforts (discussed under agenda item 14). Document ECE/TRANS/SC.2/2022/11 sets out the suggested contribution from SC.2 on these points for adoption by the Working Party.

The Working Party will also be informed about the new Inland Transport and Trade Connectivity eLearning Platform – LearnITC.
