# Prioritization for updates – topics on which discussion continues

- Prevention of pest contamination (consideration of results of work under IPPC)
- Chains of responsibilities review of definitions for terms used in the CTU Code
- Usage of terms such as placards, labels, marks and signs



# CTU mobile application

Preliminary agreement on an approach for presenting CTU Code in the APP (start simple)

- Mapping of 'typical', 'challenging' cargo products/commodities to the text in the CTU Code (layers for narrowing down the relevant searched information)
- Development of a script for first 3 cargo products
- Development of scripts for the remaining cargo products based on an agreed template

Work of the secretariat and a small group of volunteers to make specific proposals to expert meeting in 2023



# Status of work

Task 1:

- specific proposal available, feedback and comments sought
- continuation necessary on the 2-3 issues

Task 2

Continuation necessary: review of the approach, mapping and script

Participants involved in the informal pre-work recommend the work to continue in 2023



# Way forward

WP.24 may wish to decide to continue the work on Tasks 1 and 2 and requests experts to report back at the 66<sup>th</sup> session in 2023

- If possible, prepare and present consolidated document with proposed changes (task 1)
- Present the mapping and script for the App (task 2)

Modality of work

- Continuation in a formal group of experts (subject to a decision by ILO sectorial bodies in early 2023)
- Continuation of the informal pre-work
