3. Programme of work

(a) Proposed concepts and processes of the future eCMR system

At the last session, the Group of Experts discussed Informal document No. 1 which was by secretariat requested submitted the and that it be submitted ECE/TRANS/SC.1/GE.22/2023/1 at this session, taking into account the discussions of the Group at its previous session. The Group may wish to discuss and agree on the proposed concepts and processes as contained in document ECE/TRANS/SC.1/GE.22/2023/1. These concepts and processes when agreed will formulate the basis of the high-level architecture of the future eCMR system as well as of the functional specifications which should be discussed and agreed during the fifth and sixth session of the group before reporting back to SC.1 in October 2023.

(b) Customs practices concerning the use of consignment notes

The group during its previous sessions considered and noted the different uses of CMR by customs authorities consignment note made in different (ECE/TRANS/SC.1/GE.22/2022/3/Rev.1). The Group requested the secretariat to further update this document by including the case of cabotage including the relevant legislation in the European Union territory as presented by the delegation of Denmark. Furthermore, the Group of Experts discussed and appreciated Informal document Nos. 2 and 3 containing a survey which were submitted by the Uzbekistan Customs authority. The survey refers to the use of CMR consignment notes by customs authorities. The Group requested the secretariat to submit Informal document No. 2 as ECE/TRANS/SC.1/GE.22/2023/2 for this session. The Group also requested the secretariat to circulate the survey to the customs authorities of the CMR Convention contracting parties.

(c) Good practices from other digitalization initiatives

The Group in order to decide about the optimal high-level architecture for the future eCMR system as well as to find a good and practical solution for issues such as the authentication, mutual recognition etc have requested the secretariat to invite if possible experts from other Conventions or transport / customs documents (such as ATA carnet, eCIM, ePhyto and Certex) digitalization initiatives to present.
