Joint Pan-European Data Collection (JPEDC) on forests and sustainable management (1)

The 2025 cycle of the JPEDC will be carried out in coordination with the data collection process for the FAO Global Forest Resources Assessment 2025.

The coordination among both processes envisages including:

- network of national correspondents
- network of reviewers
- technical workshops
- data collection interface









JPEDC data collection - Scope

- FOREST EUROPE Criteria and indictors for SFM
- **Criterion 1:** Maintenance and Appropriate Enhancement of Forest Resources and their Contribution
- Criterion 2: Maintenance of Forest Ecosystem Health and Vitality
- Criterion 3: Maintenance and Encouragement of Productive Functions of Forests (Wood and Non-Wood)
- Criterion 4: Maintenance, Conservation and Appropriate Enhancement of Biological Diversity in Forest Ecosystems
- Criterion 5: Maintenance and Appropriate Enhancement of Protective Functions in Forest Management (Notably Soil and Water)
- Criterion 6: Maintenance of other Socioeconomic Functions and Conditions
- Forest Policy and Governance



Joint Pan-European Data Collection (JPEDC) on forests and sustainable management (2)

Joint Pan-European Data Collection (JPEDC) on forests and sustainable management (3)

The 2025 cycle of the JPEDC data collection system will be the same environment as built for the FAO Global Forest Resources Assessment 2025

It is planned that the data collection system will:

- Be functionally and visually similar to the one developed for FRA
- Attempt to coordinate reporting on the overlapping variables
- Be prefilled with data reported for 2020 pan-European reporting
- Be prefilled with the data reported through International Data Providers (IDPs)*
- Be developed into the future comprehensive data management system *

*subject of availability of funding

Joint Pan-European Data Collection (JPEDC) on forests and sustainable management (4)

2022-2023

- October 2022 January 2023:
 Development of the JPEDC system
- February 2023 March 2023: Testing the JPEDC system
- April 2023: Launch of the reporting process
- **September 2023:** Reporting data gathered through IDP
- May 2023 October 2023: Regional/sub regional workshops (Possibly back-to-back to the TOS meetings)
- December 2023: Closure of the reporting process

2023-2024

- December 2023 January 2024: Analysis of preliminary results
- **February 2024:** Conclusion of the JPEDC 2025
