2. Information on other complementary activities across the ECE region

3. Identification of stations on the AGC network to be defined as an international railway passenger hub

The Group of Experts will be invited to continue discussions on the identification of the hubs based on documents ECE/TRANS/SC.2/HUBS/2022/8 and ECE/TRANS/SC.2/HUBS/2023/3 prepared by the secretariat in collaboration with experts, incorporating comments received from experts on the definition for an International Railway Passenger Hub and on the draft list of stations to be included in a potential legal instrument.

4. Identification of the technical and service parameters necessary for the definition of an international railway passenger hub

The Group of Experts will be invited to continue discussions on what should be defined as minimum technical and service parameters for international railway passenger hubs. Discussions will focus on document ECE/TRANS/SC.2/HUBS/2023/4 prepared by the secretariat in collaboration with experts, based on the results of the consultation process agreed at the fourth session, setting out an updated list of parameters and incorporating comments received by experts. The Group may also wish to continue discussions on the role of the Guidance note on the application of the requirements relating to technical parameters in hubs identified in ECE/TRANS/SC.2/HUBS/2022/11. Finally, the Group may wish to discuss examples of pictograms and the information of provision to passengers in other sectors as set out in ECE/TRANS/SC.2/HUBS/2023/6.
