- At its 186th session in March 2022, WP29 requested all its subsidiary working parties to perform a screening of the UN Regulations and Global Technical Regulations (GTR) of relevance regarding their fitness for Automated Driving Systems (ADS) until March 2023.

- AC.2 discussion on the election procedures
- GRBP's IWG MU reported on the general approach how to handle measurement uncertainties in UN Regulations (WP.29-187-06). WP.29 invited other GRs to consider if the proposed approach could fit UN Regulations under their umbrellas. WP.29 also felt that the document of reference could serve as a guide for technical services when performing measurements.

- IWG on DETA provided a template to be used by GRs on UI implementation in UN Regulations (more details during Agenda item 11.)
- Uganda joined the 1958, 1997 and 1998 agreements
- The Philippines joined the 1958 Agreement

- high-level segment on "Actions of the inland transport sector to join the global fight against climate change" (ECE/TRANS/2023/1), Tue 21 Feb 2023
- Side-event expected on Wed 22 Feb 2023 on "Roundtable on Electric Vehicle Charging Infrastructure" (building on ECE/TRANS/2023/23); Jointly hosted by WP.5 (trends and economics), WP.6 (Transport statistics) and WP.29 (through GRPE reps, still tbd)
 - Objectives: The side event will explore the policy tools available for countries to overcome barriers to fast electrification.
 - Understanding the problems across countries require good-quality official statistics.
 Existing efforts to collect charging infrastructure statistics at the country and international levels will be shared.
 - The need for harmonized protocols globally to ensure seamless and flawless EV recharge all over the world will be assessed (both hardware and software)
 - The importance of harmonized regulation to achieve safe and fast charging, enable grid balancing and appropriate grid and recharging capacity, as well as minimize the carbon footprint of EV recharge will be explored.
