# WORKSHOP ON THE MODERNISATION OF OFFICIAL STATISTICS

## **Information Notice No. 1**

The 2015 workshop will be hosted by Statistics Netherlands, at their offices at Henri Faasdreef 312, 2492 JP The Hague, Netherlands. It will take place on 24-25 November 2015, starting at 13.30 on 24 November, and ending by 17.00 on 25 November.

### I. PURPOSE AND TARGET AUDIENCE OF THE WORKSHOP

- 1. The High-Level Group for the Modernisation of Statistical Production and Services (HLG) was created by the Bureau of the Conference of European Statisticians (CES) in 2010. It has developed a vision and strategy for the modernisation of statistical production and services, both of which have been endorsed by the CES. There are various expert groups and initiatives whose work is related to the implementation of the strategy, so the HLG would like to invite two representatives of each of these groups and initiatives to a workshop to discuss progress so far, and determine the key priorities for 2016.
- 2. The purpose of the workshop is to ensure all of the groups and initiatives represented align their work towards the implementation of a common strategy. The expected outputs are a set of agreed and prioritised implementation actions.
- 3. The target audience of the workshop is representatives of the expert groups and initiatives whose work is related to statistical modernisation. Representatives should normally include the chair or coordinator of the group or initiative, and one other person. They should canvass their groups on issues and priorities prior to the workshop. All members of the HLG Executive Board and the Modernisation Committees are also welcome to attend.

#### II. AGENDA OF THE WORKSHOP

4. The programme of the workshop will consist of the following substantive topics:

#### Day 1: Overview of the HLG projects and initiatives during 2015

5. This session will review progress on the key priorities and initiatives agreed at the 2014 workshop. The results of the projects on the implementation of the Common Statistical Production Architecture, and the use of Big Data for official statistics, will be presented for discussion and feedback. Participants will be invited to assess the extent to which these projects are meeting expectations, and delivering useful outputs.

#### Day 2: Identifying key priorities for the implementation of the strategy during 2015

- 6. Following an initial presentation, discussions in small groups and in plenary will identify the key priorities on which the HLG should focus its activities during 2015, and agree the topics for international collaboration projects during 2016.
- 7. The outcomes of the workshop will be summarised by the chair. A list of key priority actions will be agreed, including deadlines and responsibilities.

#### Side Events

- 8. The following side-events are foreseen, to take place on 23 and 26 November. Please note that they are by invitation only.
  - The Marton Vucsan Seminar on Artificial Intelligence and Official Statistics to mark the retirement of Marton Vucsan from Statistics Netherlands
  - Meetings of the HLG, the Executive Board and the modernisation committees

- 9. Participation to the workshop will be by invitation only. Each group or initiative is invited to send up to two representatives.
- 10. All participants attending the workshop are requested to have a valid passport and, if required, a visa. Applications for visas should be made as soon as possible to the Dutch Embassy in the country in which the participant resides, with a reference to the UNECE Workshop on the Modernisation of Official Statistics. A letter to facilitate obtaining a visa can be requested from the UNECE secretariat.
- 11. Invitees should inform the UNECE secretariat **before 31 July** if they intend to participate at the workshop or nominate another representative of their group.
