#### Purpose of the new publication:

- 1. Collection of good practices and case studies with reference to good practices on the data and information exchange;
- 2. Content and experience will be drawn from a range of sources, including from reporting under the Water Convention and on SDG indicator 6.5.2, from projects or other work under the Water Convention, and workshops and other meetings organized under the Convention's programme of work for 2022-2024;
- 3. The purpose of the cases is to learn from real life examples, including both the difficulties and challenges that countries face and good solutions and ways of organization that countries and joint bodies have found useful;





#### **Background of the publication:**

- At its 9th session (Geneva, 29 September 1 October 2021) the Meeting of the Parties entrusted the Working Group on Monitoring and Assessment to collect good practices and lessons learned in transboundary data exchange and synthesize them in a publication.
- Draft Outline of the new publication was prepared by the secretariat with input from lead Parties. It includes the template for the submission of cases.
- Draft Outline(*ECE/MP.WAT/WG.1/2022/INF.3-ECE/MP.WAT/WG.2/2022/INF.3*) was discussed at the Expert Meeting on Monitoring, Assessment and Data Exchange (13 and 14 April 2022) & approved at the Joint Working Group on IWRM and Monitoring and Assessment (28-30 June 2022).
