3. Programme of Work

(a) Development of proposals for amending the AETR Agreement, including Article 22bis

At the last session, the Group of Experts was informed that no bilateral meetings between the Russian Federation and European Commission have been held. As a result, no compromise solution was found related to ECE/TRANS/SC.1/GE.21/2021/2. The Russian Federation reiterated that its position remains unchanged as per ECE/TRANS/SC.1/GE.21/2021/3. The Group will be invited to continue discussing this topic.
