## II. Annotations to the Provisional Agenda


#### 1. Introduction

The United Nations Economic Commission for Europe (ECE) Working Party on Intermodal Transport and Logistics (WP.24) at its 65<sup>th</sup> session (Geneva, 19-21 October 2022) prolonged the informal pre-work on CTU Code for one more year to continue: (i) assess which areas of the CTU Code need to be prioritized in the updates, and (ii) consider text usage of the CTU Code in the mobile application. The informal pre-work is prolonged due to continuous absence of a decision on the establishment of an official group of experts on the CTU Code.

Experts participating in the informal pre-work on the CTU Code are requested to advance further the work on both tasks, and to report progress achieved to WP.24 at its 66<sup>th</sup> session in October 2023.

#### 2. Chair for the meeting

Participants may wish to appoint a chair for the meeting to facilitate the discussions.

#### 4. Updates to the CTU Code

The pre-work carried out in 2022 resulted in preparation of proposals for updates to the CTU Code as follows:

- (i) to clause 5.3 (Annex 7) on transporting solid bulk cargo in CTUs
- (ii) to clause 5.2 (Annex 7) on transport of liquids in flexitanks
- (iii) to clause 2.3 (Annex 7) on blocking material and arrangements, and review of blocking terms
- (iv) to section 4 (Appendix 4, Annex 7) on cargo securing with dunnage bags
- (v) to clause 4.2 (Annex 7) on package stability
- (vi) to clause 3.1.1 to 3.1.3 (Annex 7) to incorporate guidance for bedding arrangements in the CTU Code and in section (appendix 4, annex 7) with detailed calculations for design of bedding arrangements
- (vii) to section 3 (Annex 7) on load positioning
- (viii) to Chapter 10, new section 10.4 on stabilizers
- (ix) to clause 5.3 of Chapter 5 on acceleration coefficients for rail transport, and
- (x) consistency changes for unit of measurements

These proposals have been submitted by the secretariat to the 65<sup>th</sup> session of WP.24 and comments have been requested from ECE member States on the proposals by 24 February 2023.

The comments received are provided in:

Participants are invited to review the comments received and propose further changes to the commented clauses and sections as appropriate.

Moreover, the pre-work done in 2022 also concluded that discussion needs to continue on the following topics:

- (i) Prevention of pest contamination
- (ii) Chains of responsibilities with focus on the review of definitions for terms used in the CTU Code, and

#### (iii) Use of terms such as placards, labels, marks and signs.

#### 5. CTU Code mobile application

Further to the discussions at the second meeting in 2022, and intersessional discussions held, participants are invited to review the mechanism worked-out for assisting users in finding relevant information in the CTU Code for safe packing of CTUs. This mechanism is to filter information from the CTU Code relevant to a type of CTU used for transport, a commodity and its packaging. CTU-Code/2023/first-informal-meeting/10 provides information on the lists developed for the three selection criteria and the thinking behind.

The CTU Code sections or clauses were mapped as per these lists. In this way, the necessary material has been prepared for the development of the digital application, which should allow users a friendly and swift identification of relevant information for safe CTU packing. The mapping will be presented to participants.

Participants will then be invited to discuss next steps.
