Context

Transboundary waters account for 60 per cent of the world's freshwater flows. More than 3 billion people depend on them. Cooperation on shared resources is therefore essential to promote sustainable economic development, human and environmental health, biodiversity, climate action and resilience, disaster risk reduction, and peace. Unfortunately, cooperation in most transboundary basins is not fit to deal with future challenges and progress is too slow.

To sustain and advance cooperation, the Transboundary Water Cooperation Coalition, a diverse, multi-stakeholder coalition of actors from around the world with a wide range of functions and capacities, was formed. In preparation to the Conference, the Coalition has provided a catalysing framework for the submission of voluntary commitments on transboundary water cooperation as part of the Water Action Agenda.

The side event will highlight commitments by countries and organizations, including basin organizations, aiming to advance transboundary water cooperation.
