



## **CONCLUSIONS AND RECOMMENDATIONS**

#### **Coordination and collaboration**

- Lead coordinating agency
- Financial and human resources
  - Adequate human and financial resources
  - NSO access to data and inter-agency working groups
  - NSO access to administrative and non-traditional data sources.
  - NSO and NSS members familiarize with UNECE tools and guidance
  - UNECE to encourage regional and global organizations with initiatives to support SDG measurement and monitoring
  - Countries should act upon the Dubai Declaration's call for increased funding for measurement and monitoring
- Defining and supporting the role of national statistical offices
  - UNECE to deepen its engagement with national governments and UN Country Teams in the region to support NSOs









### **CONCLUSIONS AND RECOMMENDATIONS**

#### Modernization

UNECE should work with other regional and global organizations to assist
NSOs in moving beyond the promise of modernization



 UNECE should demonstrate leadership in the domain of SDG measurement and monitoring by working across traditional structures to support member States (Road Map on Statistics for SDGs, version 2.0)

#### Dissemination and communication

UNECE should promote the development and implementation of SDG dissemination and communication platforms and the use of standardized solutions for data and metadata transfer and exchange, following internationally agreed standards (SDMX, for example)
