#### Article 7

Decisions on the adoption of texts and the signing of international treaties, as well as on the empowerment to commit these acts, are taken in the form of the following acts: - in relation to international treaties concluded on behalf of the Republic of Tajikistan, by the Decree of the President of the Republic of Tajikistan

 Law of the Republic of Tajikistan "About international treaties of the Republic of Tajikistan"

Article 5 (Proposals for signing, ratifying, approving and acceding to international treaties)

State bodies submit the following proposals through the Ministry of Foreign Affairs of the Republic of Tajikistan, within the scope of authority:

 To the President of the Republic of Tajikistan on signing, approval of international treaties and accession to them on behalf of the Republic of Tajikistan

Article 5 Proposals for signing, ratifying, approving, accepting and acceding to international treaties contain:

a draft normative legal act on the signing of ratification, approval of international treaties and accession to them;

- substantiation of expediency of their signing, ratification, approval and accession to them;

- the conclusion of the Ministry of Foreign Affairs of the Republic of Tajikistan on the Compliance with the foreign policy expediency of concluding an international treaty;

conclusion of the Ministry of Justice of the Republic of Tajikistan on the compliance of draft international treaties with the legislation of the Republic of Tajikistan

Article 5 Proposals for signing, ratifying, approving, accepting and acceding to international treaties contain:

assessment of possible political, legal, financial, economic and other consequences of the conclusion of international treaties;

officially certified copies of the texts of international treaties;

list of states-participants of multilateral international agreements;

- translation of the text of international treaties into the state language, certified by the seal of the state body responsible for their conclusion;

a list of normative legal acts of the Republic of Tajikistan, in which, in connection with the entry into force of an international treaty, there is a need to make changes and additions;
