## **Report on cooperation with other organizations and Economic Commission for Europe bodies**

## Submitted by the secretariat

### Summary

This document provides an overview of cooperation under the Economic Commission for Europe (ECE) subprogramme on Trade during the period July 2022 – March 2023. It provides an overview of collaborative efforts of ECE with development partners and cooperation mechanisms underpinning these efforts in the following areas of work: circular economy (Section II); agricultural quality standards (Section III); regulatory cooperation and standardization policies (Section IV); and trade facilitation policies and standards (Section V).

This document also covers trade-related cooperation activities carried out in the context of the activities in response to the sixty-ninth Commission session on the topic of "Circular Economy and the Sustainable Use of Natural Resources".

The document is presented to the Steering Committee on Trade Capacity and Standards for decision.



## I. Introduction

1. This document maps cooperation under the Economic Commission for Europe (ECE) subprogramme on Trade during 2022–2023. The first part provides an overview of collaborative efforts with development partners, while the second features an account of the areas and cooperation mechanisms underpinning these efforts.

2. Sections covering activities by the United Nations Centre for Trade Facilitation and Electronic Business (UN/CEFACT) are for information only. This document also covers trade-related cooperation activities carried out in the context of the activities in response to the sixty-ninth Commission session on the topic of "Circular Economy and the Sustainable Use of Natural Resources". ECE established the internal Task Force on Circular Economy to build partnerships in the area and generate knowledge exchange within organization. It is led by Deputy Executive Secretary and all eight subprogrammes actively contribute to this Task Force, including the Trade Subprogramme.

### **II.** ECE cross-cutting work on circular economy

3. The sixty-ninth session of ECE (21–22 April 2021) was dedicated to the topic of fostering "Circular Economy and the Sustainable Use of Natural Resources". In response to a request from the Commission, the ECE Economic Cooperation and Trade Division (ECTD) pooled its efforts to mainstream circularity and the sustainable use of natural resources in the existing relevant work streams and capacity building in the ECE region, as appropriate and subject to available resources.

4. The secretariat regularly participates in related international discussions on the circular economy. Examples of recent engagements included meetings organized by the United Nations Environment Programme (UNEP); the World Trade Organisation's (WTO) Committee of Trade and Environment and WTO Trade and Environmental Sustainability Structured Discussions (TESSD); Economist Impact's Global Trade Week 2022; "Stockholm+50"; the European Development Days; the annual Circular Economy Stakeholder Conference and together with the Finnish Innovation Fund (Sitra), a contribution to World Circular Economy Forum (WCEF). The ECE organized a session on Environmental, social and governance (ESG) traceability of supply chains during the context of "Trade and Environment Week 2022". Building on conducted analytical and capacitybuilding work in the area of the circular economy transition, the secretariat, jointly with the Permanent Mission of the Republic of Uzbekistan to the United Nations Office and other international organizations in Geneva, organized a session on "Circular economy and trade: opportunities and challenges for transition economies" during the WTO Public Forum on 30 September 2022.

5. The ECE launched a project on "Accelerating the Transition towards a Circular Economy in the ECE region" (2021–2024), funded by the 13th tranche of UNDA. The project established a stakeholder engagement platform, Circular STEP. As of April 2023, there are 25 member States who nominated official focal points for the network. The platform facilitates exchanges of experience and best practices among stakeholders in the region for circular economy transition, including Governments, the private sector, academic and research institutions, civil society, and other actors from all 56 member States. Circular STEP partners with key circularity players, such as the Ellen MacArthur Foundation, the Finnish Innovation Fund (Sitra), the Friedrich-Ebert-Stiftung, Chatham House, United Nations Development Organization (UNIDO), UNEP, Industrial the International Telecommunications Union, the University of Cambridge, and Lund University.

## III. Agricultural Quality Standards

6. Within the framework of Working Party 7 on Agricultural Quality Standards (WP.7), ECE continues to collaborate with the four other regional commissions (RCs) and with the Food and Agriculture Organization (FAO) and other relevant United Nations organizations on issues related to food systems and food loss and waste. In particular, through the regional

issue-based coalition on sustainable food systems (IBC-SFS) for Europe and Central Asia, which aims to advocate for and facilitate coordinated support for strengthening sustainable food systems in the region of Europe and Central Asia, ECE collaborates closely with FAO, the International Fund for Agricultural Development (IFAD), the United Nations Development Programme (UNDP), United Nations Children's Fund (UNICEF), World Food Programme (WFP), World Health Organization (WHO), and World Metrological Organization (WMO).

7. Recent activities have included contributions to the 2022 Regional Overview of Food Security and Nutrition in Europe and Central Asia, and the joint organization of several webinars including on "Sustainable Food Systems to Build Back Better in Europe and Central Asia", held as a side-event to the Regional Forum on Sustainable Development (RFSD) in April 2022, and on "How is the Ukraine-Russia conflict affecting food systems in Europe and Central Asia" (14 July 2022). ECE is also collaborating with the UN Food Systems Coordination Hub and the IBC-SFS in the organization of the regional preparatory meeting for the food systems stock-taking moment, held in connection with the RFSD on 28 March 2023, in preparation for the global Food Systems Stock-Taking Moment scheduled for July 2023.<sup>1</sup>

8. ECE continues to work closely with the Organisation for Economic Co-operation and Development (OECD) Fruit and Vegetables Scheme to facilitate the common interpretation of ECE standards and their application in international trade. It cooperates with the FAO Codex Alimentarius Committees on Fresh Fruits and Vegetables and on Processed Fruits and Vegetables in developing new commercial quality standards and maintaining existing ones. ECE and OECD has collaborated on a study to assess the impact of ECE agricultural quality standards and OECD explanatory material on the trade of fresh fruit and vegetables. The study, which is based on regression analysis at product level, finds conclusive evidence that trade in various types of fresh fruits and vegetables increases, in general, in the period after revision of an ECE standard. The study also showed that trade in the products were higher between countries which had adopted the standards than with other countries. Finally, coordination with the European Commission is ongoing to ensure continued harmonization of EU marketing standards with ECE standards.

## **IV.** Regulatory Cooperation and Standardization Policies

### A. Cooperation with international and regional organizations

9. Through the Working Party on Regulatory Cooperation and Standardization Policies (WP.6), ECE is an observer at the World Trade Organization (WTO) Committee on Technical Barriers to Trade (TBT). ECE participates in the official meetings of the TBT Committee. The work on market surveillance, conformity assessment, risk management and education on standardization are all key themes that are often on the table of WTO discussions. The ECE secretariat provides input on these as well as on the importance of gender-responsive standards.

10. Collaboration with the International Trade Center (ITC) has culminated in the joint publication of a guide for border regulators on "Managing Risk for Safe, Efficient Trade." This publication provides guidance on the application of WP.6 recommendations P on "Risk Management in Regulatory Systems," R on "Managing Risk in Regulatory Frameworks," S on "Applying Predictive Risk Management Tools for Targeted Market Surveillance," T on "Standards and Regulations for Sustainable Development" and V on "Addressing Product Non-Compliance Risks in International Trade". This cooperation has assisted the ECE secretariat in reaching a larger audience and finding funding to develop and publish these guidelines.

11. WP.6 is active in cross-cutting themes of the United Nations. It has actively participated in meetings of the United Nations Office for Disaster Risk Reduction (UNDRR) to promote the implementation of international standards as tools for the reduction of disaster risks. It has been actively engaged on the ECE response to the UN-Women "UN-SWAP for mainstreaming gender equality", integrating many of the key concepts into the gender-responsive standards workflow. It has also taken into consideration the UN Disability Inclusion Strategy of the sub-working group of the Inter-Agency Support Group on the Convention on the Rights of Persons with Disabilities, notably through the development of videos with closed captioning and through the integration of disability considerations in the evaluation of extra-budgetary projects.

12. ECE strengthened cooperation with the United Nations Entity for Gender Equality and the Empowerment of Women (UN-Women) in support of gender-responsive standards. WP.6 has identified meaningful areas where cooperation with UN-Women could help to bring this work to another level, such as linking gender-responsive standards to the general national policies on gender as well as monitoring and measuring the results of this standards work. UN-Women has been consulted in the potential organization of a new extra-budgetary project on gender-responsive standards, the implementation of which is subject to finding donor funding.

13. WP.6 works with many regional organizations for the promotion of its work, notably the gender-responsive standards workflow. Many of these regional organizations are signatories to the Gender-Responsive Standards Declaration, and they encourage their membership to adopt the principles of this Declaration and to become signatories themselves. This includes very active participation from the European Committee for Standardization (CEN) and the European Committee for Electrotechnical Standardization (CENELEC) – the organizations that develop European Standards; the African Organization for Standardisation (ARSO); the Standards and Metrology Institute for Islamic Countries (SMIIC) and the Pan American Standards Commission (COPANT).

# **B.** Cooperation with standard setting and quality infrastructure organizations

### Standardization policies

14. The standardization community continues to support the work of WP.6. The Declaration for Gender-Responsive Standards and Standards Development has been signed to date by eighty organizations including 50 national standards bodies from all continents; and all major international standards organizations (the International Organization for Standardization (ISO), ITU, International Electrotechnical Commission (IEC), voluntary sustainability standards organizations and regional standards bodies.<sup>2</sup>

15. Another important area of ECE collaboration with over thirty standards bodies has been the portal "Standards for the SDGs". The secretariat has been working with major international standards setting bodies to update this portal, such as ASTM International, CODEX, International Civil Aviation Organization (ICAO), IEC, International Electrical and Electronics Engineers (IEEE), ISO and World Intellectual Property Organization (WIPO). This online resource increases awareness of policymakers on how standards support the achievement of the goals and targets of Agenda 2030. It features a mapping tool, a repository of case studies as well as supporting training materials (https://standards4sdgs.unece.org/). The portal hosts over thirty thousand standards mapped and over forty case studies.

16. WP.6 also partners closely with IEC in support of two sectoral initiatives, respectively on equipment used in environments with an explosive atmosphere and on cybersecurity. The first of these benefits from the support of the IEC System for Certification to Standards Relating to Equipment for Use in Explosive Atmosphere (IECEx) and the other from the IEC Conformity Assessment Board (CAB).

17. WP.6 participates actively in several key technical committees (TC) of ISO, notably ISO TC 262 on Risk Management where WP.6 is a member of the Strategic Alliance and Regulatory Group (STAR), and provides strategic advice to the ISO Committee on Conformity Assessment (ISO/CASCO). WP.6 has also established liaison with the ISO TC 232 on Education and Learning Services. WP.6 also benefits from an in-depth cooperation with the ISO central secretariat, collaborating on key themes such as gender-responsive standards, education on standardization and standards in support of the SDGs.

## Metrology and other areas of the national and international system of quality infrastructure

18. WP.6 works in partnership with national, regional, and international institutions that lay the foundations of the quality infrastructure systems. In this area, the closest partner is the German Physikalisch-Technische Bundesanstalt (PTB), which was also the major donor of the extrabudgetary projects on "Usage and Uptake of Voluntary Standards" and "Standards for the SDGs".

19. Other close partners in this area are the Bureau International des Poids et Mesures (BIPM), the International Accreditation Forum (IAF), IEC, the International Laboratory Accreditation Cooperation (ILAC), the International Organization of Legal Metrology (OIML), the International Committee for Legal Metrology (CIML), ISO, ITU and UNIDO. The cooperation is currently crystalized through a project to update the Recommendation K on "Metrological Assurance of Conformity Assessment and Testing," expected to be completed in 2023.

20. Since 2010, the WP 6 has been a member of the "International Network on Quality Infrastructure" (previously Network on Metrology, Accreditation and Standardization for Developing Countries (DCMAS)), which includes: BIPM, IAF, IEC, ILAC, ISO, ITU, OIML, and UNIDO, the World Bank and the WTO. The cooperation includes sharing expertise and mutual participation in meetings.

#### Cooperation with academia

21. WP.6 approved at its 31<sup>st</sup> session in 2022 the establishment of a focal point network of academia experts. The network is to ensure that education on standardization is integrated into curricula of non-technical students so that they are prepared with a base knowledge of the requirements and expectations when they enter the workforce. The first meeting of this network took place on 1 March 2023 where a path forward for further bringing this work to students was presented and best practices of the use of the currently available material was shared.

## V. Trade Facilitation Policies and Standards

### A. Cooperation with international and standard-setting organizations

### Trade facilitation

22. Trade facilitation and electronic business play a key role in the trade-related aspects of addressing value chain disruptions and ensuring sustainable and resilient recovery. UN/CEFACT, serviced by ECTD has been at the forefront of trade facilitation and digitalization for several decades and it is very well placed to address global and regional challenges, through developing and deploying global standards and digital solutions as well as enhancing traceability and transparency along value chains.

23. The five RCs have taken a joint approach to trade facilitation, which was decided by the Executive Secretaries of the commissions in Beirut in January 2010 and subsequently endorsed by all five RCs. In 2015, they launched the first Survey on Trade Facilitation and Paperless Trade, which was followed by the biennial editions in 2017, 2019 and 2021. The five RCs have jointly developed an online portal (untfsurvey.org) to help countries visualize and compare the implementation of measures across regions and economies.

24. Under the UNDA 14th tranche, the five RCs developed the project "Blockchains for facilitating trade and enhancing competitiveness". This project, which is led by the United Nations Economic and Social Commission for Western Asia (ESCWA), aims to strengthen national innovation and technological capacities related to the use of blockchain technology in customs and trade operations in five selected developing countries. It is expected that its implementation will boost trade and enhance competitiveness in support of sustainable development. ECE is the RC that is more advanced in the implementation of blockchain technology for trade, considering that extensive work was done on this topic since 2017.

25. ECE has cooperated with WTO, GIZ, and other organizations on the implementation of the SPECA Trade Facilitation Strategy, for example on the publication of a guide on establishing a trade facilitation enquiry point<sup>3</sup>, and a series of events on various measures in the WTO Agreement on Trade Facilitation (TFA).

### Digitalization

26. ECE is co-chairing (with the Head of the ITU Office for Europe) the United Nations Group for Digital Transformation in Europe and Central Asia (DTG4ECA)<sup>4</sup>. Together with the DTG4ECA, the UN/CEFACT secretariat co-organized two virtual events in the context of the ECE Regional Forum for Sustainable Development 2022 on the topics related to digital transformations and accelerating digital developments.

27. The secretariat has also chaired (on a rotational basis) the Management Group of Memorandum of Understanding on e-Business between the International Organization of Standards (ISO), International Electrotechnical Commission (IEC), ITU and ECE, and hosted its last meeting. This group of experts ensures intersectoral coherence in the field of e-business, avoiding overlap and duplication among organizations and fostering digitalization.

28. The secretariat was invited to contribute to the ICC Digital Standards Initiative (DSI), including the inputs to the WTO-ICC Standards Toolkit for Cross-Border Paperless Trade (of which out of 100 standards presented in the Toolkit, around 20 are from frameworks and initiatives of UN/CEFACT); and the engagement in the ICC DSI/Industry Advisory Board Working Group on Key Trade Documents and Data Elements. The Working Group produced the paper "ICC DSI Key Trade Documents & Data Elements Standards Analysis and Recommendations", published at the end of March 2023.

#### Transparency and traceability

29. Enhancing transparency and traceability of sustainable value chains in the garment and footwear sector project is implemented by ECE through its UN/CEFACT in close cooperation with ITC, OECD, UNEP, UNCTAD, UNDP, GIZ, IFC, Better Cotton Initiative (BCI), FAO, Global Fashion Alliance, the International Labour Organization (ILO), the United Nations Global Compact, CITES, government institutions and the private sector (business associations and private companies), academia, think tanks and non-governmental organizations. The pilot to harness the potential of blockchain technology for due diligence and traceability in cotton and leather value chains involves suppliers, manufacturers, brands, standard setting bodies and technology solution providers.

30. Under the Sustainability Pledge, ECE collaborated with leading regional actors, including the Bocconi University School of Management, FAO, ITC, the United Nations Economic Commission for Latin America and the Caribbean (UNECLAC), UNIDO, World Bank – International Finance Corporation (WB-IFC), the German Organisation for International Cooperation (GIZ), and has involved government agencies from host countries and the sub-regions.

31. For the implementation of the UNDA project on "COVID-19 Trade and Transport Connectivity" and the follow-up to the UNDA 14th tranche joint transport and trade project "Sustainable mobility and smart connectivity(trade and transport nexus) in Central Asia, the Caucasus and Western Balkans", ECE collaborated with the European Commission, DG

MOVE and DG TAXUD, which use the ECE and UN/CEFACT package of standards in the implementation of the EU Regulations on Electronic Freight Transport (eFTI) and Customs Single Window. Other organizations with which ECE collaborates on the implementation of the package for multimodal data and document exchange include the ICAO, the IMO, the Organization for Cooperation of Railways (OSJD), the International Committee on Railway Transport (CIT), The Transport Corridor Europe-Caucasus-Central Asia (TRACECA), the UN Commission on International Trade Law (UNCITRAL) and others.

### Joint activities with ISO

32. Over the past year, UN/CEFACT has seen a peak in interest in its work on dematerialization and in the UN/CEFACT standard development. For example, ISO technical committee 154 adopted the UN/CEFACT Buy-Ship-Pay Reference Data Model (BSP RDM) as an ISO standard (ISO 20197). It will provide a foundation to align future ISO standards related to e-commerce data exchange with UN/CEFACT BSP RDM. The Global Standards 1 (GS1) organization has actively engaged to harmonize their ongoing work with the Buy-Ship-Pay Reference Data Model. The ICAO and the International Maritime Organization (IMO) have both sought the assistance of UN/CEFACT to dematerialize their processes.

33. The ECE secretariat has closely followed the official category-A liaisons with ISO TCs. These include ISO TC 46 (Information and documentation), ISO TC 154 (Processes, data elements and documents in commerce, industry and administration), and the category-B liaison with ISO TC 68 (Financial services). Together with the Sustainable Transport Division, a new category-B liaison was set up with ISO TC 315 (Cold chain logistics) last year. The secretariat is closely working with ISO TC 154 on the Terms of Reference for joint activities and hosted its last Plenary Meeting.

### Information Exchange

34. The FAO Global Record Working Group (GRWG) and the Agreement on Port State Measures (PSMA) Technical Working Group on Information Exchange (TWG-IE) resumed their in-person meetings after the COVID-19 pandemic. FAO acknowledged the importance of ensuring that all designated ports under PSMA should be attributed a United Nations Code for Trade and Transport Locations (UN/LOCODE), and they insured that they will closely cooperate with ECE on this. A study paper was jointly drafted with FAO on the use of UN/LOCODE for the FAO Global Record in order to combat illegal, unreported and unregulated (IUU) fishing. In addition, the secretariat will study feasibility to identify small fish ports with UN/LOCODE. In this way, the FAO Global Record will become the backbone of international fisheries management as it provides the relevant vessels and their activities record.

35. The secretariat was invited to join the review panel to review the e-learning course on the implementation of the Maritime Single Window (MSW), developed by IMO by using the UN/CEFACT materials, which will be available to IMO web account users as an open access E-Learning Course through the IMO Learning Management System portal. The secretariat was also involved in the Correspondence Group on developing the Guidelines for Harmonised Communication and Electronic Exchange of Operational Data for Port Calls.

36. Jointly with ESCAP, the secretariat closely cooperates with the CITES secretariat on the Task Force on Electronic CITES Permit Exchange (EPIX), aiming to support the stakeholders to initiate and carry out pilot-based and/or live electronic exchange of CITES permits in order to contribute to the prevention of fraudulent use of CITES permits and facilitate legal trade.
